Preface

Why This Investigation Matters Now

There has never been a time in human history when belief has been so aggressively interrogated—and so casually dismissed.

You are living in an age where information is instant, opinions are loud, and certainty is rare. In this environment, the question is no longer “*What is true?*” but rather “*What can be proven?*” And nowhere is this demand for proof more intensely applied than in the case of Jesus Christ.
