Allow me to introduce:

Let me introduce myself nicely: My name is Cor, I grew up in various places in the Netherlands, we moved around quite often. By profession, I am a research technician. My specialization in a broad sense are visualization techniques. I am fascinated by God's creation and how He has beautifully realized everything within His perfectly set laws of nature and the beautiful firmament that tells the works of His hands. Happily married to my beautiful wife Nelma, my mainstay, in charge of many control activities, a jack-of-all-trades who largely takes care of our four children. Fortunately, she grants me the time and space to write this book for which I am very grateful.

During my childhood my father ran evangelical bookshops in various places in the Netherlands (which was the reason we moved around quite often). My mother always had children's work on her mind, so I was brought up religiously but at some point I felt it was important to investigate whether Christianity was right. That was the beginning of a long journey and rollercoaster of wonderful discoveries I was allowed to make.

My Father on my mother's side was a boatman and had an entire Library, a well-read man and was already steeped in the fact that Jesus will soon return to earth. In his younger days, my father published a Holy Spirit-inspired booklet called, *The Bridegroom Comes*. So from the generation line of both my mother's and father's side, there was interest and search for the return of Jesus Christ. At the beginning of my long journey of discovery, I developed an appetite for the Word. When I read the Bible, texts became three-dimensional, so to speak. In particular, the prophetic books were unlocked for me. What had previously been bloody, violent & ominous texts turned into texts that God kept His people on the right path precisely through judgement and discipline. In this, the prophets were and are God's messengers who prophesied warnings of what would happen if the people did not repent. When people repented, prophecies of doom were postponed, relieved or lifted. I saw that God has been working on a restoration plan for humanity for thousands of years. But also that God is carrying out many restoration steps in a kind of hiddenness.

Isaiah 45:

¹⁵*Truly You are God, who hide Yourself, O God of Israel, the Savior!*

I was allowed to receive many valuable insights from God during this journey, I have come to realize that God has total omnipotence and that His plans of restoration and completion lie again behind the nefarious plans of the adversary. He can even use evil to work out good. What was also a very interesting discovery was that God timed everything to His divine timing. I came to the incredible discovery that throughout history, numerous divine timelines run from divine sign/prophetic restoration to divine sign/prophetic restoration. That God has, as it were, encoded these divine timelines with numbers corresponding to key Biblical texts, so called principles. Later in the book we will elaborate more on these timelines. That God thereby shows, as it were, that all power belongs to Him and that He ultimately has total control over world events. That everything is in His hand and that He will not let go of the works of His hands.

I also had the privilege of discovering that there are still numerous contemporary Divine messengers (Modern Day Prophets) carrying God's messages. And that the Bible offers the tools (along with the anointing of God's Spirit) to distinguish the true from the false prophets.

This is also one of the reasons I like to give space to the voice of God through His prophets in this book. The fulfillment of these prophetic messages are presented, as far as possible, in a chronological order so that you get a picture of what you, the reader, can expect in the next two years (detailed) and the following years of the great things that God is carrying out.

[You are presented with world news, so to speak, well before it is world news.](#) Here the scripture passage from Isaiah 46 (next page) is very much in place:

Isaiah 46:

⁹ Remember the former things, those of long ago; I am God, and there is no other; I am God, and there is none like me.

¹⁰ I make known the end from the beginning, from ancient times, what is still to come. I say, 'My purpose will stand, and I will do all that I please.'

Despite the, at first glance, worrying & turbulent times, there will be a great awakening of mankind with an associated great worldwide revival of the body of Christ, His church. I would like to take you, the reader, on a wonderful journey of great things God is doing now, and what incredible things He will do in the very near future. A future that you and I will be in the midst of.

In the first part of the book I mainly elaborate on the decade-long nefarious plans the adversary is trying to implement, long-running agendas. And how exactly we got into this situation. The second part of the book, in turn, deals with current affairs, what is going on at the global level, the news you don't get from the established media channels.

The last part of the book deals in great detail with the voice of God's prophets and outlines a prophetic panorama. To the best of my ability, I have put down all the prophetic messages in a kind of chronological order of fulfillment. Not always easy because there is quite some overlap in time. Some prophetic messages are very detailed and cover a short span of time and other prophetic messages cover a longer period of time and are less detailed. It was a very rewarding and uplifting work to create this overview. In this work, I was drawn to the following Scripture passages:

Amos 3

1 Corinthians 2

⁷....we speak the wisdom of God in a mystery, the hidden wisdom which God ordained before the ages for our glory, (relates also to the voices of the prophets)

⁹....as it is written:

"Eye has not seen, nor ear heard, Nor have entered into the heart of man The things which God has prepared for those who love Him."

¹⁰....God has revealed them to us through His Spirit. For the Spirit searches all things, yes, the deep things of God. ¹¹....no one knows the things of God except the Spirit of God. ¹² Now we have received, not the spirit of the world, but the Spirit who is from God, that we might know the things that have been freely given to us by God.

1 Corinthians 13

⁸ Love never fails. But whether there are prophecies, they will fail; whether there are tongues, they will cease; whether there is knowledge, it will vanish away. ⁹ For we know in part and we prophesy in part. ¹⁰ But when that which is perfect has come, then that which is in part will be done away.

And with verses 8-10 in 1 Corinthians 13 I want to indicate that perfection in this is of course impossible but that on the other hand God also does not leave us in the dark about the great things He is doing.

Parts of the outlined prophetic panorama, sketched in this book, are combined with celestial signs that God has appointed at set times on the firmament and how His divine signs are related to prophetic fulfillments. These celestial signs include impressive solar eclipses, blood moons and the Revelation 12 sign. The Revelation 12 verse 1-2 sign is a very important sign, placed in the firmament on a special day because it is linked (on that particular day) in time to numerous prophetic fulfillment, more on that later.

A word of advice: please do not read this comprehensive book in a chronological order, just pick out what interests you first, what you are most intrigued by, you can always take in other passages later on. Take notes and go on a journey within this book, discovering the wonders of God's kingdom, powerfully paving through oppressive times and the role, or noble task, you may play in it.

General Preface, mainly on Volume Part V—Voices modern day Prophets: Visions, Prophecies & Dreams

Do you believe in a God? And I don't just mean a god doing his own thing in some vague place, some kind of vague force somewhere. No I mean a super omnipotent God who is also passionate about getting to know His Creatures, you/you, better, who very much wants a living relationship with YOU. Who wants to use YOU as a reader to build His kingdom. If you do not know God, it is highly advisable to start by reading the first four books of the Bible of the New Testament, Mathew, Mark, Luke & John, that paints a beautiful picture, what God has for you and that He wants a living relationship with you. It is possible to be employed by an almighty God and live a life that has real value, a life that has full meaning, having real valuable relationships with fellow brothers and sisters. To build as living stones (The body of Christ) for the imperishable kingdom to come. This is very different from just trying to figure out on your own what you can best do in life to hopefully make something meaningful out of it. That, if you try hard enough, with a bit of luck, you will be mentioned in the annals of history. This book shows that God really exists, that He is super creative, intelligent and all-powerful but also a God in the background in the hidden as it were, read Isaiah 45:15. 2022 was already a turbulent year with all the weather extremes, food shortages and a war in the Ukraine that is becoming more and more grotesque but is nothing compared to the year 2023. But in all this turbulence, God is rolling out His almighty plan of salvation for mankind with surgical precision, and this is bound to be accompanied by upheavals. These upheavals are necessary to chop off the head of the evil that is now rampant behind the scenes. There will be astonishing unmasking of dark plans in the year 2023. Already you can see Elon Musk, with his takeover of Twitter, rolling out the dark practices, such as the collusion of Big Tech companies to de-platform people or the 2020 election interference scandal revealed in the twitter files.

If you look now at what is currently going on in the world, building tensions between major power blocs like NATO on the one hand and China, Russia, the BRIC countries Iran & OPEC on the other, you may be shocked. But these times too are foretold in the Bible, read

Matthew 24: 6-8

And you will hear of wars and rumours of wars. See that you are not troubled; for all these things must come to pass, but the end is not yet. For nation will rise against nation, and kingdom against kingdom. And there will be famines, pestilences, and earthquakes in various places. All these are the beginning of sorrows.

So it is just the very beginning of what we can expect! So what specifically can we expect in 2023? That is largely what this book is about, to be read in the next passage:

Part V-Voices modern-day Prophets: Visions, Prophecies & Dreams

It says in Amos 3:7 that God does nothing without revealing it to His servants the prophets. So He tells it first and only then proceeds to do it. That He does it that way is to also give people a chance to repent of their evil ways. As you saw, among other things, in the Bible book Jonah and the city of Nineveh. The king and the people of the city of Nineveh repented of their evil ways and God spared the city.

Similarly, high-ranking leaders have a chance to break with the globalist agendas they now fully support and seek to implement.

The big question is whether they will actually do that. It seems to me that they feel untouchable, highly exalted above the people and that their hearts are hardened, just as was the case with Pharaoh in Egypt, Who did not want to let God's people go either, preferring to exploit them as slaves, eventually ten severe plagues followed and Pharaoh let the people go. An exodus from Egypt (exodus) followed under God's mighty hand. There is a very strong parallel in these Biblical events and what God is currently bringing about. He is phasing us out of the globalist agenda that the rulers of this world are desperately trying to implement. What God intends to do He tells us through His servants the prophets. The tricky thing, however, is that prophetic messages reflect only part of the overall picture, sometimes very detailed and over a short span of time, sometimes, on the contrary, very expansive in time and less detailed. Sometimes a prophecy actually highlights the spiritual struggles of an unseen but oh so realistic world. And sometimes certain events are skipped altogether, as if a cut in time has been made. A striking example of this can be found in the Bible:

Isaiah 9:

*⁶ For unto us a Child is born, Unto us a Son is given;
And the government will be upon His shoulder.
And His name will be called Wonderful, Counsellor, Mighty God,
Everlasting Father, Prince of Peace.*

This is of course about Jesus, but what is completely missing here is that Jesus was also beaten on the cross for our sins and died for our sins, to pay the debt for us.

This is why many Jews did not understand at all what was going on, they thought that their saviour, Jesus would become the great king of Israel, that He would ensure long-lasting peace and prosperity and free them from Roman rule. Jesus in His loving grace explained this to the Emmaus goers, a very beautiful piece, to be read in the Bible: Luke 24:13-40.

But herewith I sketch, based on how I have been given to interpret the prophetic messages as best I can, a picture of what we can expect in 2023:

A further intensification of wars; there is expected to be a spring event (Israel-Iran probably) that will give an introduction to a devastating Middle East war, this will be the war described in Isaiah 17, Psalm 83 and Zechariah 11:1-3. As a result of this war, the economy will totally collapse. (This war will take place around Rosh Hashanah, September 16, 2023 is my expectation). Simultaneously, food shortages will further increase, among other things, by banning fertilisers (nitrogen policy), weather extremes and sabotaging food storage depositories. These food shortages will manifest sharply in the months of September, October and December 2023. Mid-year, the Biden administration will fall, There will be a major coverup of the fact that Joe Biden has died, later his double will also die. Kamala Harris will first play along (through blackmail) in the play that Joe Biden's doppelganger takes over but will eventually be unable to stomach this and bring out the truth. With the help of the US military, Donald J. Trump will return to power. Also US states will secede from the federal government in protest.

A presidential election will be organised and held on 7 November 2023. Trump will win these by more than 100 million votes. Before these elections take place, tsunamis will inundate cities located on the east coast of America. In the run-up to this presidential election, I expect new viruses/biological weapons to be unleashed on the world's population, and new vaccination programmes to be deployed. These viruses/biological weapons will also leave deep scars in Europe. By God's hand, these pathogens will backfire on the people who introduced these biological weapons.

It is possible that these tsunamis are the result of an asteroid impact that will take place around 31 October 2023. It is also quite possible that artificial tsunamis, are created by Russian Poseidon nukes. Italy is also expected to be heavily affected by asteroid impacts, the Mediterranean sea will rise to unexplainable heights and Italian islands will be partially inundated.

With tsunamis flooding US coastal cities, God is reckoning with the "Democratic" camp that will again try to steal the election. After Trump's election victory is obvious, the globalists will deploy their far left shock troops, including BLM troops, to create chaos and anarchy that way. When China and Russia see how divided America is they will launch their long-planned invasion. The day on which this invasion will begin is expected to be 24 December 2023. Before this invasion, China will lay siege to Taiwan, much to the dismay of European leaders. America will strike at the bait and come to Taiwan's aid with its fleet. China will fire an atomic bomb towards America and it will be deliberately detonated centrally over America, high in the atmosphere. ²⁰ For the creation was subjected to futility, not willingly, but because of Him who subjected it in hope; ²¹ because the creation itself also will be delivered from the bondage of corruption into the glorious liberty of the children of God. ²² For we know that the whole creation groans and labours with birth pangs together until now.

Are you ready for this rollercoaster? I wish you every blessing and strength to live a life in connection with God the Father.

Foreword PART I-IV:

Dear reader, I totally assumed, like everybody else, that Donald Trump would initially, just be inaugurated on January 20, 2021. And that all the fraudulent practices of the deep state would be revealed before that. That a series of lawsuits in the federal courts all the way to the supreme court would be won. That the swing states would compile their own electoral lists and that Mike Pence would reject electoral votes from the swing states for Jo Biden. Only none of that happened. So, had a spirit of lies been active all these years making all the prophets wrong? That seemed strong to me. I then started digging further into all the prophecies again. And began to understand that God deliberately did this to expose all corruption...

Currently, decades-long agendas are being implemented by the so-called globalists, or at least they are trying to. It could very well be that if you are reading this you are thinking, "Ah there's another nutty freedom fighter with his conspiracy theories." Who sees behind every government measure put in place an evil plan aimed at reducing the world's population. Who, with his deluded fantasies, can almost be seen as a danger to the population of right-thinking people who feel socially responsible for general safety and stand for group interests. An example of feeling socially responsible is protecting others by receiving vaccinations so that viruses have less of a hold on the population. Dissenters can then be seen as irresponsible and even anti-social; placing them just a little too quickly into a particular pigeonhole. And so we are directly confronted with our pigeonholing.

Having a pigeonhole mind is often seen as being narrow-minded and making snap judgements, stigmatising someone. Yet this is a very natural psychological process. As human beings, we like to maintain order in a disorderly mush of information coming at us. Our filtering mechanisms are useful tools for this: we filter, categorise and separate minor and major issues. These are natural unconscious psychological processes that we perform on our sensory world, the external stimuli that come in. Yet it is good to be aware of these. Every person tends to build and maintain their own truth bubble. This gives a sense of security, we then feel that we have our position clearer in relation to external stimuli that come in, how authority relations are, the way society is structured and how we relate to it. What are the best actions based on our position in society that result in our life preservation, or that of the groups of people we feel connected to. This is also why information at odds with our truth bubble is often written off as erroneous or only adopted as truth when a torrent of evidence is brought to the table. When a robust amount of conflicting information bursts our truth bubble, it will hurt us psychologically.

We then feel disoriented and may temporarily lose confidence in the world/society around us but also lose confidence in our own judgement. We may then feel incapable and naive. Therefore, even at first, on a subconscious level, we will do everything we can to defend our truth bubble and protect it.

In my view, it is good, even as a reader, to recognize these processes. And thereby truth bubble conflicting information can easily be classified as conspiracy thinker information. Where does the term conspiracy thinker actually come from? How did it come about?

Since the Warren Commission concluded that a lone gunman killed President John F. Kennedy, people who doubt that conclusion have been widely dismissed as conspiracy theorists, despite credible evidence that right-wing elements in the CIA, FBI and Secret Service - and possibly even senior government officials - were also involved. The suspicion of criminal misconduct at the highest levels of government seems to be rejected outright as paranoid thinking akin to superstition.

The founding fathers' harsh realism about the likelihood of elite political misconduct - articulated in the Declaration of Independence - has been replaced by the current blanket condemnation of conspiracy belief as inherently ridiculous. The term "conspiracy theory" entered the American lexicon of political speech to deflect criticism of the Warren Commission and can be traced back to a CIA propaganda campaign to discredit doubters of the commission's report. To sum up, I would like you to want to look with an open mind at the, sometimes explosive, information described in this book in order to gain as much benefit from this knowledge as possible for your preservation.

Currently, we are no longer on the eve of a dizzying chain of significant events, no we are already in the middle of it. Woke agendas are being rolled out at an accelerated pace, as are sustainable goals to which national interests are being sacrificed, these agendas are being instilled in our children in schools. The composition of international power blocs is shifting rapidly. Partly because of the war in Ukraine, these global power blocs are crystallising at an accelerated pace, with countries taking joint positions. Europe, UK and USA under the NATO flag on the one hand and Russia, Iran and China, OPEC and the BRICS on the other. Turkey, in turn, plays a dual role in this. Tensions are also gradually rising again in the Middle East. The development of the Iranian nuclear programme is watched with suspicion by Israel. In addition, the current energy crisis in the West, due in part to sanctions and "sustainable" energy policies, means that many countries are trying to secure their energy revenues, which again could be a potential source of future conflict. Since Nancy Pelosi's visit to Taiwan, seen by China as a renegade province, Taiwan's straits have been violated more frequently by Chinese naval units. Also brewing is a future conflict between India and China. China is preparing for combat readiness and working behind the scenes with Russia to dethrone America as the strongest power.

The Proxy War in Ukraine being fought by, on the one hand, Europe, UK and the USA, united under the NATO umbrella, and on the other hand, Russia being supported by the China, Iran and OPEC. The strategy is that OPEC deliberately pumps up fewer barrels of oil, and thereby keeping the price of oil high, this allows Russia to sell its petroleum products at a good price to other markets, such as China and India. Matthew 24:

*"... many false prophets will rise up and deceive many. ¹² And because lawlessness will abound, the love of many will grow cold. ¹³ But he who endures to the end shall be saved. ¹⁴ And this gospel of the kingdom will be preached in all the world **as a witness to all the nations**, and then the end will come.*

During this wave of revival, the evil one will already sow new errors to lead people astray from true faith in the God of the Bible. My expectation is that it need not be a prosperous period economically. Humanity will also face great challenges in this period of revival, but in connection with God, these difficult issues will be surmountable. I will briefly elaborate on the series of events I expect to take place around the world, it will be a roller coaster ride that has not taken place on this world before:...

Right now the globalists, the shadow government are doing everything they can to bring down America, undermine her economically. One example, when Biden hobbled to the Oval Office he signed several executive orders including the end of construction of the Keystone XL Pipeline. Canceling the Keystone Pipeline cost over 11,000 construction jobs and 42,100 jobs throughout the US during the construction process according to the US State Department.

In addition, by the Biden administration, the borders of the southern border have been opened wide. President Donald J. Trump, in his first term, did the best he could to seal off this southern border from immigrants who threatened to flood the southern border. Unfortunately, many effective measures of the southern border policy have been reversed by the Biden administration.

On March 9, 2021, Donald Trump issued a statement accusing Democrats of destroying the country with a dangerous open borders policy: "When I was President, our Southern border was in great shape – stronger, safer, and more secure than ever before," Trump said. "We ended Catch-and-Release, shut down asylum fraud, and crippled the vicious smugglers, drug dealers, and human traffickers. Our country is being destroyed at the Southern border, a terrible thing to see!"

For better understanding, I will briefly touch upon age-old agendas that are ongoing and which the ruling class behind the scenes is currently desperately trying to accelerate. For that, we will first take a backward glance in time and key figures in our near history, as well as highlight certain terms related to it in more detail:

PART I The long-term strategy of the global new world order: Implementing the Great Reset

First an explanation/summary of the globalist agenda and the long term strategies being pushed by the globalists to implement a great reset. What is the great reset and how long are the preparations? What is the purpose of the great reset? In the coming chapters a rough outline will be given. The Great Reset, also known as: The Fourth Industrial Revolution / Agenda 21 / The New World Order / 'Build Back Better'

The Great Reset is the name of the 50th meeting of the World Economic Forum, held in June 2020. In October 2020 Peter Koenig (Author of The Global Research website at www.globalresearch.ca) called it "the antidote to 'democracy'". As envisioned, it appears to be a total corporate takeover of all aspects of life.

Using a technocratic bio-security state apparatus to implement the changes, it will mean extensive restrictions on the physical environment around people, a forced digitalization, and a loss of bodily autonomy (i.e., control over your own health decisions)."

Build Back Better is a slogan that goes with the policy.

The project aims to connect "key leaders from governments and businesses worldwide" in "a historic moment to shape the system for the post-coronation era." A solution to "stakeholder capitalism" is envisioned, with large corporations becoming "trusted agents of society."

What is striking in all these plans is the absence of democratic participation, where people can actually decide their own future at the local level. The democratic process in the Great Reset is reduced to the involvement of global government leaders and "stakeholders," i.e. self-appointed community leaders from NGOs, who usually take positions aligned with those of big business.

The launch of the forum also strongly alludes to a lowering of material living standards for the average citizen (but perhaps not so much for business owners or Prince Charles), especially in developed countries; "a lifestyle change" to a green economy, including pushing for "rapid growth in digital"-as opposed to physical goods and services, such as travel. The launch mentions "employment opportunities" and "opportunities for all" to "close the gaps in equality," but does not mention living standards.

The Great Reset concept is strongly promoted by WEF Executive Chairman Klaus Schwab, who envisions a "comprehensive approach" to shaping the future that integrates "all organizations and people with innovative ideas." Who these people and organizations are and what kinds of ideas will be prominent can be gleaned from the speakers at the initiative's launch: Kristalina Georgieva of the IMF, Brad Smith of Microsoft, Bernard Looney of British Petroleum and Prince Charles of Great Britain. And the strategic partners who will help formulate the action plan include some 100 of the world's most ruthless companies.

Deep State: Follow the Rothschild, Soros, and Rockefeller Money

It may sound cliché, but there is a great deal of wisdom in the old saying about catching criminals: "Follow the money." That advice applies as much to catching small-time petty thieves as it does to big-time global crime syndicates. And it is especially relevant when trying to understand the bureaucratic and intelligence community components of the "Deep State," and more importantly, the "Deep State Behind the Deep State." This shadowy network, which is barely concealed at this point, includes secret societies such as Skull and Bones and the Bohemian Grove, as well as less-secretive organizations such as the Council on Foreign Relations, the Trilateral Commission, and the Bilderberg meetings. Money is key.

Of course, much of what has been referred to amid the Trump era as the "Deep State" is merely part of the government — the legions of entrenched Big Government bureaucrats and especially the Central Intelligence Agency (CIA), the National Security Agency (NSA), and other secretive agencies.

"Washington is the most important node of the Deep State that has taken over America, invisible threads of money and ambition connect the town to other nodes. One is Wall Street, which supplies the cash that keeps the political machine quiescent and operating as a diversionary marionette theater. Should the politicians forget their lines and threaten the status quo, Wall Street floods the town with cash and lawyers to help the hired hands remember their own best interests."

To be short, a tiny group of entities — mostly financial institutions and especially central banks — exert a massive amount of influence over the international economy from behind the scenes.

Agenda 21 & ONE WORLD GOVERNMENT

Agenda 21 is a two-decade old, grand plan for global 'Sustainable Development,' brought to you from the United Nations. George H.W. Bush (and 177 other world leaders) agreed to it back in 1992, and in 1995, Bill Clinton signed Executive Order #12858, creating a Presidential Council on 'Sustainable Development.' This effectively pushed the UN plan into America's large, churning government machine without the need for any review or discussion by Congress or the American people.

'Sustainable Development' sounds like a nice idea, until you scratch the surface and find that Agenda 21 and Sustainable Development are really cloaked plans to impose the tenets of Social Justice/Socialism on the world.

The following things are at risk from Agenda 21: Private Property ownership, Single-Family homes, Private car ownership, individual travel choices & Privately owned farms. And what role does the illustrious figure George Soros play in these agendas, questions that will be answered in the coming passages.

George Soros: A influencer behind the Curtains

New York hedge fund manager George Soros is one of the most politically powerful individuals on earth. Since the mid-1980s in particular, he has used his immense influence to help reconfigure the political landscapes of several countries around the world—in some cases playing a key role in toppling regimes that had held the reins of government for years, even decades. *Vis à vis* the United States, a strong case can be made for the claim that Soros today affects American politics and culture more profoundly than any other living person.

Much of Soros's influence derives from his multi-billion-dollar personal fortune, which has been further leveraged by investor assets controlled by his firm, Soros Fund Management (SFM). As of 2011, SFM's assets totaled approximately \$28 billion. An equally significant source of Soros's power, however, is his passionate messianic zeal. Soros views himself as a missionary with something of a divine mandate to transform the world and its institutions into something better—as he sees it.

Soros's Roots & Development

George Soros was born to Tivadar and Erzebat Schwartz, non-practicing Jews, in Budapest, Hungary on August 12, 1930. Tivadar was an attorney by profession, but the consuming passion of his life was the promotion of Esperanto—an artificial, "universal" language created during the 1880s in hopes that people worldwide might be persuaded to drop their native tongues and speak Esperanto instead—thereby, in theory at least, minimizing their nationalist impulses while advancing intercultural harmony. In 1936, Tivadar changed his family surname to Soros—a future-tense Esperanto verb meaning "will soar." When the Nazis occupied Budapest in 1944, Tivadar decided to split up his family so as to minimize the chance that all its members would be killed together.

For each of them—his wife and two sons—he purchased forged papers identifying them as Christians; paid government officials to conceal his family's Jewish heritage from the German and Hungarian fascists; and bribed Gentile families to take them into their homes. As for George in particular, the father paid a Hungarian government official named Baumbach to claim George as his Christian godson, "Sandor Kiss," and to let the boy live with him in Budapest. One of Baumbach's duties was to deliver deportation notices to Hungary's Jews, confiscating their property and turning it over to Germany. Young George Soros sometimes accompanied the official on his rounds.

Soros has repeatedly called 1944 "the best year of his life." 70% of Mr. Soros's fellow Jews in Hungary, nearly a half-million human beings, were annihilated in that year, yet he gives no sign that this put any damper on his elation, either at the time, or indeed in retrospect". During an interview with *Sixty Minute's* with Steve Kroft, Soros was asked about his "best year."

KROFT: My understanding is that you went out with this protector of yours who swore that you were his adopted godson.

SOROS: Yes. Yes.

KROFT: Went out, in fact, and helped in the confiscation of property from your fellow Jews, friends, and neighbors.

SOROS: Yes. That's right. Yes.

KROFT: I mean, that sounds like an experience that would send lots of people to the psychiatric couch for many, many, years. Was it difficult?

SOROS: No, not at all. Not at all, I rather enjoyed it.

KROFT: No feelings of guilt?

SOROS: No, only feelings of absolute power!

After WWII, Soros attended the London School of Economics, where he fell under the thrall of fellow atheist and Hungarian, Karl Popper, one of his professors. Popper was a mentor to Soros until Popper's death in 1994. Two of Popper's most influential teachings concerned "the open society," and Fallibilism.

Fallibilism is the philosophical doctrine that all claims of knowledge could, in principle, be mistaken. (Then again, I could be wrong about that ☹) The "open society" basically refers to a "test and evaluate" approach to social engineering. Regarding "open society," Roy Childs writes, "Since the Second World War, most of the Western democracies have followed Popper's advice about piecemeal social engineering and democratic social reform, and it has gotten them into a grand mess."

In 1956 Soros moved to New York City, where he worked on Wall Street, and started amassing his fortune. He specialized in hedge funds and currency speculation. Soros is absolutely ruthless, amoral, and clever in his business dealings, and quickly made his fortune. By the 1980s he was well on his way to becoming the global powerhouse he is today.

In 1959 Soros moved to Greenwich Village, New York, where early stirrings of the Sixties counterculture were already being felt. In September 1960 he married Annaliese Witschak, who would be his wife until the couple divorced 23 years later. In 1961 Soros became a U.S. citizen, and two years later he and Annaliese had their first child, a son. In the Village, it is likely that Soros was exposed to the ideas of the prominent socialist Michael Harrington, who mingled with fellow radicals and socialists almost nightly at a tavern situated barely a stone's throw from Soros's residence.

Soros the Philanthropist

It was in 1979 that Soros began testing the proverbial waters of philanthropy. Five years later he launched, in the country of his birth, the first of his many Open Society Foundations—named after the concept advanced by Karl Popper—to help “build vibrant and tolerant democracies whose governments are accountable to their citizens.” But it was not until 1987, the year he opened his Moscow office, that Soros began to disseminate truly large amounts of money to various groups and causes. “My spending rose from \$3 million in 1987 to more than \$300 million a year by 1992,” he said. During this period, Soros established a series of foundations throughout Eastern Europe and Central Asia. He happily observed that because of his extraordinary wealth, major political figures “suddenly became very interested in seeing me.... my influence increased.” Today Soros's Open Society Foundations are active in more than 120 countries around the world.

In 1993 Soros established the flagship of the Soros foundation network—the New York City-based Open Society Foundations (OSF), which went by the name of the Open Society Institute until 2010. While OSF’s philanthropy extends to a number of nations around the world, it is chiefly devoted to injecting capital into American groups and causes.

Entrusted with the task of defining the foregoing terms for the OSF, and for articulating OSF’s agendas from the outset, was Aryeh Neier, whom Soros appointed to serve as president not only of OSF, but of the entire Soros Foundation Network. Neier worked fifteen years for the American Civil Liberties Union (ACLU)—including eight years as its national executive director. After that, he spent twelve years as executive director of Human Rights Watch (HRW), an organization he founded in 1978.

A open society is a term coined by French philosopher Henri Bergson in 1932, and describes a dynamic system inclined to moral universalism. Bergson contrasted an open society with what he called a closed society, a closed system of law, morality or religion. Bergson suggests that if all traces of civilization were to disappear, the instincts of the closed society for including or excluding others would remain.

And here we immediately see that the venom of the snake is in the tail. At first glance, these open societies seem like a nice endeavour but according to the definition, this open society is diametrically opposed to laws, morality and religion. And this so-called open society is hostile to faith, the Christian faith and thereby hostile to the true freedom that Christian faith offers. What we get now is slavery wrapped in an idea of freedom. This open society is also strongly left/progressive in orientation. Legalising and facilitating abortion programs are high on its agenda. It is therefore also obvious that George Soros and his open society programmes are highly regarded at the World Economic Forum Website and treated with all due respect at the site, his vote counts! The WEF has reaped many rewards from George Soros' preliminary work done, how to establish learning programmes and place potential influencers (associated with these institutions) in key positions and thus steer society? It is also extremely important for the WEF to push its agenda through, and social influence/steering plays a big role in this. We therefore see that in numerous influential political & social positions, people are positioned who are connected to the WEF and support its ideas.

The Soros Agendas

Both the ACLU and HRW have long promoted one of the central contentions of Soros’s Open Society Foundations: the notion that America is institutionally an oppressive nation and a habitual violator of human rights both at home and abroad. Consider first the ACLU, whose advisory board once included the former Weather Underground terrorist Bernardine Dohrn. The ACLU has opposed virtually all post-9/11 national security measures enacted by the U.S. government, depicting those measures not only as excessively harsh and invasive generally, but also as discriminatory against Muslims in particular. Moreover, the organization has filed numerous lawsuits seeking to limit the government’s ability to locate, monitor, and apprehend terrorist operatives. It consistently depicts American society as one that is rife with intractable racial injustice. And it works tirelessly to protect illegal immigrants against “governmental abuse and discrimination.”

Neier’s other training ground, Human Rights Watch, has a long history of pointing an accusatory finger at America’s allegedly numerous transgressions. Most notably, HRW has derided the U.S. war on terror as a foolhardy endeavor rooted in blindness to the realization that terrorism stems, in large measure, from America’s failure “to promote fundamental rights around the world.

In a March 2007 speech, HRW executive director Kenneth Roth charged that the United States, by routinely “using torture and inhumane treatment” to deal with its foes, had “severely damaged its credibility when it comes to promoting human rights” in other nations.

The shrewd influence of the general public: The Sundance Institute

In 1996, Soros launched his Soros Documentary Fund to produce “social justice” films that would “spur awareness, action and social change.” In 2001, this Fund became part of actor-director Robert Redford’s Sundance Institute. Between 1996 and 2008, OSF earmarked at least \$5.2 million for the production of several hundred documentaries, many of which were highly critical of capitalism, American society, or Western culture generally. In 2009, Soros pledged another \$5 million to the Sundance Institute.

Organizations that seek to inject the American judicial system with leftist values:

The *Alliance for Justice* consistently depicts Republican judicial nominees as “radical right-wing[ers]” and “extremists” whose views range far outside the boundaries of mainstream public opinion.

The *American Constitution Society for Law and Policy* seeks to indoctrinate young law students to view the Constitution as an evolving or “living” document, and to reject “conservative buzzwords such as ‘originalism’ and ‘strict construction.’”

Justice at Stake promotes legislation that would replace judicial elections with a “merit-selection” system where a small committee of legal elites, unaccountable to the public, would pick those most “qualified” to serve as judges. OSF has spent at least \$45.4 million on efforts to change the way judges are chosen in many American states.

Organizations that advance leftist agendas by infiltrating churches and religious congregations:

Catholics in Alliance for the Common Good advocates a brand of “social justice” that would counteract the “greed, materialism, and excessive individualism” that are allegedly inherent in capitalism.

Sojourners characterizes wealth redistribution as the fulfillment of a biblical mandate. Jim Wallis, the founder of this evangelical Christian ministry, has expressed his hope that “more Christians will come to view the world through Marxist eyes.”

People Improving Communities through Organizing uses “people of faith” as foot soldiers in its crusade for the “transformation” of “people, institutions, and ... our larger culture.”

Catholics for Choice—formerly known as Catholics for a Free Choice—is a nominally Catholic organization that “believes in a world where everyone has equal access to ... safe and legal abortion services.”

Think tanks that promote leftist policies:

The Institute for Policy Studies has long supported Communist and anti-American causes around the world. It seeks to provide a corrective to the “unrestrained greed” of “markets and individualism.”

The New America Foundation tries to influence public opinion on such topics as healthcare, environmentalism, energy policy, and global governance.

The *Urban Institute* favors socialized medicine, expansion of the federal welfare bureaucracy, and tax hikes for higher income-earners.

Organizations that promote radical environmentalism:

Groups in this category typically oppose mining and logging initiatives, commercial fishing enterprises, development and construction in wilderness areas, the use of coal, the use of pesticides, and oil and gas exploration in “environmentally sensitive” locations. Moreover, they claim that human industrial activity leads to excessive carbon-dioxide emissions which, in turn, cause a potentially cataclysmic phenomenon called “global warming.” Examples of such Soros donees include *the Alliance for Climate Protection*, *Earthjustice*, *the Earth Island Institute*, *Friends of the Earth*, *Green For All*, and the *Natural Resources Defense Council*.

Another major recipient of Soros money is the *Tides Foundation*, which receives cash from all manner of donors—individuals, groups, and other foundations—and then funnels it to designated left-wing recipients. Having given hundreds of millions of dollars to “*progressive nonprofit organizations*” since 2000, Tides is a heavy backer of environmental organizations, though its philanthropy extends also into many other areas.

George Soros presents himself as an environmentalist of the first order and is quick to condemn industrial corporations for allegedly trampling recklessly over the earth’s ecosystems in pursuit of the almighty dollar. But in fact, Soros himself has proven to be quite willing to despoil Mother Nature in exchange for profits of his own. Consider, for example, his involvement in the Argentine beef industry, which environmentalists claim is responsible for massive levels of water pollution and deforestation. Argentina’s biggest landowner is none other than George Soros, with some 500,000 hectares of land and 150,000 head of cattle to his name. Moreover, Soros has been a part owner of Apex Silver Mines, which operates in a remote and ecologically sensitive region of Bolivia.

Organizations that promote modern-day feminism’s

The core tenet of these organisations is that America is fundamentally a sexist society where discrimination and violence against women have reached epidemic proportions:

The *Feminist Majority Foundation* “focuses on advancing the legal, social and political equality of women with men, countering the backlash to women’s advancement, and recruiting and training young feminists.”

The *Ms. Foundation for Women* laments that although “women are more than half the [U.S.] population ... they don’t have equal opportunity, voice or power.”

The *National Partnership for Women and Families* asserts that “women today are still paid only \$0.77 to a man’s dollar”—an assertion that is grossly misleading and substantively untrue.

Women's rights and abortion the deceptive mix

Soros donates to the following organizations that promote women's right to taxpayer-funded abortion on demand:

Planned Parenthood, the *National Abortion Federation*, the *Center for Reproductive Rights*, *Choice USA*, *NARAL Pro-Choice America* & the *National Abortion Federation*.

Organizations that favor global government which would bring American foreign policy under the control of the United Nations or other international bodies:

According to George Soros, “We need some global system of political decision-making. In short, we need a global society to support our global economy.” Consistent with this perspective, the *Open Society Foundations* in 2008 gave \$150,000 to the *United Nations Foundation*, which “works to broaden support for the UN through advocacy and public outreach.”

Moreover, OSF is considered a “major” funder of the Coalition for an *International Criminal Court*, which aims to subordinate American criminal-justice procedures in certain cases to an international prosecutor who could initiate capricious or politically motivated prosecutions of U.S. officials and military officers.

And financial trail of destruction, Soros' growing empire at the expense of others

In an article Kyle-Anne Shiver wrote for *The American Thinker* she says, "Soros made his first billion in 1992 by shorting the British pound with leveraged billions in financial bets, and became known as the man who broke the Bank of England. He broke it on the backs of hard-working British citizens who immediately saw their homes severely devalued and their life savings cut drastically, almost overnight" In 1994 Soros crowed in *The New Republic*, that "the former Soviet Empire is now called the Soros Empire." The Russia-gate scandal in 1999, which almost collapsed the Russian economy, was labeled by Rep. Jim Leach, then head of the House Banking Committee, to be "one of the greatest social robberies in human history. The "Soros Empire" indeed.

In 1997 Soros almost destroyed the economies of Thailand and Malaysia. At the time, Malaysia's Prime Minister, Mahathir Mohammad, called Soros "a villain, and a moron." Thai activist Weng Tojirakarn said, "We regard George Soros as a kind of Dracula. He sucks the blood from the people."

The website *Greek National Pride* reports, "Soros was part of the full court press that dismantled Yugoslavia and caused trouble in Georgia, Ukraine, and Myanmar [Burma]. Calling himself a philanthropist, Soros' role is to tighten the ideological stranglehold of globalization and the New World Order while promoting his own financial gain. He is without conscience; a capitalist who functions with absolute amorality."

France has upheld an earlier conviction against Soros, for felony insider trading. Soros was fined 2.9 million dollars. Recently, his native Hungary fined Soros 2.2 million dollars for "illegal market manipulation." Elizabeth Crum writes that the Hungarian economy has been in a state of transition as the country seeks to become more financially stable and westernized. Soros deliberately driving down the share price of its largest bank put Hungary's economy into a wicked tailspin, one from which it is still trying to recover.

My point here is that Soros is a planetary parasite. His grasp, greed, and gluttony have a global reach. But what about America? Soros told Australia's national newspaper *The Australian*: "America, as the center of the globalized financial markets, was sucking up the savings of the world. This is now over. The game is out," he said, adding that the time has come for "a very serious adjustment in American's consumption habits." He implied that he was the one with the power to bring this about.

SOROS: "World financial crisis was stimulating, and in a way, the culmination of my life's work." Obama has in the recent past promised 10 billion of our tax dollars to Brazil, in order to give them a leg-up in expanding their offshore oil fields. Obama's largesse towards Brazil came shortly after his political financial backer, George Soros, invested heavily in Brazilian oil, (Petrobras).

Tait Trussel writes, "The Petrobras loan may be a windfall for Soros and Brazil, but it is a bad deal for the U.S. The American Petroleum Institute estimates that oil exploration in the U S could create 160,000 new, well-paying jobs, as well as \$1.7 trillion in revenues to federal, state, and local governments, all while fostering greater energy security and independence."

A blog you might want to keep an eye on is SorosWatch.com. Their mission: "This blog is dedicated to all who have suffered due to the ruthless financial pursuits of George Soros. Their stories are many and varied, but the theme is the same: the destructive power of greed without conscience. We pledge to tirelessly watch Soros wherever he goes, and to print the truth in the hope that he will one day be made to stop preying upon the world's poor, that justice will be served."

Back to America. Soros has been actively working to destroy America from the inside out for some years now. People have been warning us.

Two years ago, news sources reported, "Soros is an extremist who wants open borders, a one-world foreign policy, legalized drugs, euthanasia, and on and on. This is off-the-chart dangerous. In 1997 Rachel Ehrenfeld wrote, "Soros uses his philanthropy to change, or more accurately deconstruct the moral values and attitudes of the Western world, and particularly of the American people." His "open society" is not about freedom; it is about license. His vision rejects the notion of ordered liberty, in favor of a PROGRESSIVE ideology of rights and entitlements.

Perhaps the most important of these "whistle blowers" are David Horowitz and Richard Poe. Their book, *The Shadow Party*, outlines in detail how Soros hijacked the Democratic Party, and now owns it lock, stock, and barrel. Soros has been packing the Democratic Party with radicals, and ousting moderate Democrats for years. The Shadow Party became the Shadow Government, which recently became the Obama Administration, and life's work since he left office...

DiscoverTheNetworks.org (another good source) writes, "By his [Soros'] own admission, he helped engineer coups in Slovakia, Croatia, Georgia, and Yugoslavia. When Soros targets a country for "regime change," he begins by creating a shadow government, a fully formed government-in-exile, ready to assume power when the opportunity arises. The Shadow Party he has built in America greatly resembles those he has created in other countries prior to instigating a coup."

Soros's Political Campaign Contributions

November 2008 edition of the German magazine, *Der Spiegel*, in which Soros gives his opinion on what the next POTUS (President of the U. S.) should do after taking office. "I think we need a large stimulus package." Soros thought that around 600 billion would be about right. Soros also said that "I think Obama presents us a great opportunity to finally deal with global warming, and energy dependence. The U.S. needs a cap and trade system with auctioning of licenses for emissions rights." Although Soros doesn't (yet) own the Republican Party, like he does the Democrats, make no mistake, his tentacles are spread throughout the Republican Party as well.

Soros is a partner in the Carlyle Group where he has invested more than 100 million dollars. According to an article by *The Baltimore Chronicle's* Alice Cherbonnier, the Carlyle Group is run by "a veritable who's who of former Republican leaders," from CIA man, Frank Carlucci, to CIA head, and ex-President George Bush, Sr.

In late 2006, Soros bought about 2 million shares of Halliburton, Dick Cheney's old stomping grounds. When the Democrats and Republicans held their conventions in 2000, Soros held Shadow Party conventions in the same cities, at the same time.

In 2008, Soros donated \$5,000,000,000 (that's Five Billion) to the Democratic National Committee, DNC, to insure Obama's win and wins for many other Alinsky trained Radical Rules Anti-American Socialists. George has been contributing a billion plus to the DNC since Clinton came on the scene. Soros has dirtied both sides of the aisle. And if that weren't bad enough, he has long held connections with the CIA. And I mustn't forget to mention Soros' involvement with the MSM (Main Stream Media), the entertainment industry (e.g. he owns 2.6 million shares of Time Warner), and the various political advertising organizations he funnels millions to. In short, George Soros controls or influences most of the MSM.

Apart from the billions of dollars that Soros's foundation network has donated to leftist groups like those cited above, Soros personally has made campaign contributions to such notable political candidates as Joe Biden, Barbara Boxer, Sherrod Brown, Bill Clinton, Hillary Clinton, Jon Corzine, Howard Dean, Richard Durbin, Lane Evans, Al Franken, Al Gore, Tom Harkin, Maurice Hinchey, John Kerry, Dennis Kucinich, Patrick Leahy, Barack Obama, Charles Rangel, Harry Reid, Ken Salazar, Charles Schumer, Joe Sestak, and Tom Udall. He also has given large sums of money to the Democratic Congressional Campaign Committee, the Democratic National Committee Services Corporation, and the Democratic Senatorial Campaign Committee.

Soros Meets the Clintons

Around the time that George Soros initially launched his Manhattan-based Open Society Foundations, he established what would prove to be a warm and enduring relationship with Bill and Hillary Clinton, the new American President and First Lady. When the Clintons took office in early 1993, they faced the daunting task of helping the collapsed Soviet empire rise from its ruins and cultivate a harmonious relationship with the United States. To lead this endeavor, President Clinton appointed three men: Treasury Department official Lawrence Summers, Vice President Al Gore, and soon-to-be State Department official Strobe Talbott.

Talbott in particular was given a large degree of authority, prompting some observers to dub him as Clinton's "Russian policy czar."¹⁵⁰ It so happened that Talbot had an exceptionally high regard for the financial expertise of George Soros—describing him as "a national resource, indeed, a national treasure"—and thus he recruited the billionaire to serve as a key advisor on U.S.-Russian matters.

As the Nineties progressed, it became increasingly evident that Bill and Hillary Clinton embraced virtually all of the values and agendas that George Soros was funding through his Open Society Foundations. "I do now have great access in the Clinton administration," said Soros in 1995. "There is no question about this. We actually work together as a team."

Soros and Mrs. Clinton in particular held one another in the highest esteem. In November 1997, when Hillary was in Central Asia for a ribbon-cutting ceremony at the newly built American University of Kyrgyzstan, she delivered a speech in which she lavished praise on Soros's Open Society Foundations, which had financed the school's construction. According to Center for American Democracy director Rachel Ehrenfeld, one source close to Mrs. Clinton's inner circle reports that Soros visited Hillary at the White House during the Bill Clinton impeachment proceedings of 1998-99, when the First Lady was receiving only her most trusted confidantes. A few years later, at a June 2004 "Take Back America" conference in Washington, Mrs. Clinton introduced Soros as a courageous man who loved his country deeply. "We need people like George Soros," she said, "who is fearless, and willing to step up when it counts." Soros, in turn, indicated that he was "very proud to be introduced" by someone for whom he had such "great admiration." He described Hillary as someone who had been "more effective than most of our statesmen in propagating democracy, freedom, and open society."

Conflicting agenda's: Soros, False flag 9/11 & The War on Terror

September 11, 2001 was a watershed moment not only in American history but also in George Soros's philanthropic career. Soros viewed the 9/11 terrorist attacks as confirmation that U.S. foreign policy—particularly under President George W. Bush, who had taken office eight months earlier—was moving in a dangerous direction, giving rise to anti-American hatred in the hearts of people all across the globe. By Soros's reckoning, Bush embodied the very antithesis of the "open society" ideal. Specifically, the billionaire detested what he viewed as the arrogance the President displayed when he publicly branded America's enemies as "evil"; when he unapologetically expressed his faith in the exceptionalism of his own culture; and when he seemed disinclined to consider the possibility that the terrorists may have had something valuable to teach Americans about how the rest of the world perceived the United States.

By the time the U.S. invaded Iraq in early 2003, Soros's contempt for President Bush's "imperialist vision" had reached a fever pitch. Accusing Bush of "deliberately fostering fear because it helps to keep the nation lined up behind the president," Soros added cynically: "Terrorism is the ideal enemy. It is invisible and therefore never disappears. An enemy that poses a genuine and recognized threat can effectively hold a nation together."

In August, Soros warned that the very “fate of the world depends on the United States, and President Bush is leading us in the wrong direction” with his “false and dangerous” doctrine. In the fall, Soros referred to Bush administration officials and Republicans generally as “extremists” who “don’t believe in the system of democracy as we know it”; and who embraced “a very dangerous ideology” which held that “the United States ... should impose its power, impose its will and its interests on the world.”

Soros’s Previous Political Interventions Around the World

By no means was this the first time that Soros had aimed to engineer the fall of a government which he deemed oppressive. On several previous occasions, he had used his extraordinary wealth to bankroll popular movements seeking to undermine communist and authoritarian regimes in Eastern Europe and Central Asia. Specifically, Soros had funded the training, organization and mobilization of many millions of demonstrators who took part in a series of bloodless political revolutions—commonly known as “velvet revolutions” or “color revolutions”—that ultimately brought down governments in those regions. Typically, these mobilizations consisted of massive street rallies (sometimes with hundreds of thousands of participants) and carefully coordinated acts of civil disobedience such as sit-ins and general strikes. In several instances, such Soros-funded protesters challenged the results of popular elections and accused incumbent leaders of election fraud—charges which were then echoed by Soros-funded exit pollsters and Soros-funded media outlets, thereby greatly amplifying the effect of the accusations. A brief survey of Soros’s most noteworthy foreign interventions will be useful at this point.

Soros helped bankroll “Charter 77,” a 1976 document demanding that the Czech government recognize some basic human rights—most notably the freedom to express religious beliefs or political opinions without fear of retributive discrimination—that were already guaranteed by the nation’s constitution. This Charter and the political movement that grew from it ultimately culminated in the velvet revolution that brought down Czechoslovakia’s Communist regime in late 1989.

Soros funding played a critical role in promoting other upheavals in the former Soviet bloc as well. “My foundations,” boasts Soros, “contributed to Democratic regime change in Slovakia in 1998, Croatia in 1999, and Yugoslavia in 2000, mobilizing civil society to get rid of Vladimir Meciar, Franjo Tudjman, and Slobodan Milosevic, respectively.”

Meciar, for his part, was a hardline nationalist whose authoritarian government—characterized by demagoguery, corruption, and hostility toward the Hungarian minority—brought instability and isolation to Slovakia in the mid-1990s. Croatian president Tudjman was likewise an autocrat infamous for his brutality, extreme nationalism, indifference to civil rights, and manipulation of electoral processes. And Milosevic, who served as president of Serbia and Yugoslavia in the 1990s, was an infamous architect of military aggression, war crimes, and ethnic cleansing. British journalist Neil Clark reports that from 1991 to 2000, Soros and his Open Society Foundations methodically laid the groundwork for the movement that ultimately led to Milosevic’s resignation, “channel[ing] more than \$100m to the coffers of the anti-Milosevic opposition, funding political parties, publishing houses and ‘independent’ media...” In a 1996 speech, [Croatian President Franjo Tudjman](#) offered a profound insight into how Soros typically injected his influence into the political workings of a given nation by patiently and systematically infiltrating strategic organizations and governmental agencies:

**** Quote Speech****

“Soros and his allies have spread their tentacles throughout the whole of our society. Soros had approval to gather and distribute humanitarian aid. However, we allowed them to do almost whatever they wanted. They have involved in their network people of all ages and classes trying to win them over by financial aid. Their aim is control of all spheres of life setting up a state within a state.”

**** End Quotation ****

Soros also funded Soviet Georgia’s “Rose Revolution,” a popular movement that forced Georgian president Eduard Shevardnadze to resign in November 2003.

According to Canada's Globe and Mail, in February of that year Soros "began laying the brick work for the toppling" of Shevardnadze. "That month, funds from his Open Society Foundations sent a ... Georgian activist ... to Serbia to meet with members of the resistance movement and learn how they used street demonstrations to topple dictator Slobodan Milosevic." That summer, Soros brought some of those Serbian activists to Georgia to train student activists there. Meanwhile, a Soros-funded television station aired weekly broadcasts of the documentary *Bringing Down a Dictator*, which presented a step-by-step account of the overthrow of Milosevic and played a crucial role in training Georgian insurgents. In the autumn months, Soros spent some \$42 million preparing the overthrow movement to mobilize. Then, in mid-November, large-scale anti-government demonstrations spread like wildfire in most of Georgia's major cities. Shevardnadze, able to read the proverbial writing on the wall, resigned within a matter of days. Soros later told the Los Angeles Times, "I'm delighted by what happened in Georgia, and I take great pride in having contributed to it." In November 2003, the editor of an English-language daily based in Georgia said, "It's generally accepted public opinion here that Mr. Soros is the person who planned Shevardnadze's overthrow." Notably, some people who worked for Soros' organizations—including two of the Open Society Georgia Foundation's former executive directors—later assumed influential positions in the new Georgian government.

Soros thereafter would go on to fund the "Orange Revolution," a series of protests and political events that took place in Ukraine from late November 2004 to January 2005, ultimately forcing Moscow's favored candidate, Prime Minister Viktor Yanukovich, to lose a controversial and hotly contested presidential election. Also in early 2005, Soros helped finance the "Tulip Revolution"—a massive protest movement that led to the overthrow of President Askar Akayev and his government in the Central Asian republic of Kyrgyzstan.

Other narratives & programs embraced and discussed on the WEF forum

The Metaverse

There were, of course, discussions on the way the Metaverse is shaping the future. Perhaps the biggest announcement involves the WEF's new initiative "Defining and Building the Metaverse". The WEF says the initiative will "*bring together key stakeholders to build an economically viable, interoperable, safe and inclusive metaverse*".

The announcement was welcomed by Stephanie Burns of Sony Interactive Entertainment, Brad Smith, President and Vice-Chair of Microsoft, Nick Clegg, former deputy prime minister of the U.K. and President of Global Affairs with Meta (formerly Facebook), and Peggy Johnson of Magic Leap Inc, formerly the CEO of Microsoft and involved in the ID2020 project.

Peggy Johnson also participated in a panel titled "Shaping a Shared Future: Making the Metaverse". Microsoft CEO Satya Nadella also participated in a panel with WEF Founder Klaus Schwab discussing the Metaverse and the future of work.

WEF Wants To Brainwash Students On The Metaverse

The World Economic Forum (WEF) announced it was taking a key leading role in the metaverse and envisions a world where it's used to 'educate' students from home to stop climate change. Much like WEF founder Klaus Schwab says that he "penetrate[s] the cabinets" of nations around the world, so too does the WEF say the metaverse needs to penetrate education systems on a global scale.

"Advancements in technology have penetrated most sectors and transformed them administratively or in service delivery. The transformation, however, still needs further technological advancements to disrupt education. These advancements' infiltration of education systems has become an increasing imperative," reads a World Economic Forum article.

According to the WEF, this "infiltration of education systems" is imperative to meet the net-zero carbon commitments of hypocritical globalist leaders who flew private jets to the COP26 climate change conference last year.

Pfizer And Vaccines

Despite two years having passed since the World Health Organizations announcement of a "global pandemic", the topic of vaccinations was high on the list of priorities, especially as corporate media begins to sound the alarm on "a new wave of COVID-19 infections" and concerns about Monkeypox (TLAV will be investigating the Monkeypox situation as it develops).

Pharmaceutical giant Pfizer committed to providing all of their current and future patent-protected medicines on a not-for-profit basis to 45 low-income nations. The move was announced by Pfizer CEO Alberto Bourla. He made no mention of adverse reactions caused by Pfizer's COVID-19 injections.

The Next Pandemic

Another panel titled “Preparing for the Next Pandemic”, featured Billy Boy; Peter Sands, Executive Director, The Global Fund To Fight AIDS, Tuberculosis & Malaria; Helen E. Clark of the WHO; and Francis deSouza, President and Chief Executive Officer, Illumina Inc. The presence of deSouza and Illumina is an interesting choice, especially in regards to the “next pandemic”, because the company deals with DNA sequencing and genomics.

Additionally, there was a panel titled “The Post-Pandemic City: Not Business as Usual”, featuring speakers imagining how a city might change in the post-COVID-19 world. Interestingly, participating in the panel is Francis Suarez, Mayor of Miami and President of the United States Conference of Mayors. This detail is worth noting as an example of how a global agenda — Agenda 2030, climate change, sustainable design — starts at places like the WEF and filters its way down to the local level where it is implemented by local officials like Mayor Suarez.

Climate Change

Of course, climate change was a hot topic throughout the week. There were strong words from Xie Zhenhua, China’s Special Envoy for Climate Change, saying words were not enough. *“It isn’t just about words anymore – it is about action. Climate action, now, is critical.”*

Also, US Special Presidential Envoy for Climate John Kerry said the only way forward was to *“radically change our economic system and our reliance on fossil fuels”* over the next 8 years. Kerry also noted that *“we have the technology to change, we need the political will. If we can harness this, we can still avoid the worst effects of climate change.”*

Commitment To Carbon Removal

When it comes to specific actions taken by the globalists “in the name of fighting climate change”, a new public-private partnership was announced focused on carbon capture programs. The so-called First Movers Coalition is focused on cleaning up the most carbon-intensive industry sectors. During the WEF meeting the coalition announced a major expansion to more than 50 corporate members worth about \$8.5 trillion and a total of nine leading governments.

John Kerry made the announcement alongside Billy Boy, founder of Breakthrough Energy. The coalition welcomed new nations India, Japan, and Sweden to the Steering Board, as well as Denmark, Italy, Norway, Singapore, and the United Kingdom as government partners.

Corporations signing on for the First Movers Coalition include Alphabet, Microsoft, AES, Aveva, Ball Corporation, BHP, Consolidated Contractors Company, Ecolab, Enel, EY, FedEx, Ford Motor Company, HeidelbergCement, Mitsui O.S.K. Lines, National Grid, Novelis, PWC, Schneider Electric, Swiss Re, and Vestas.

Environmental, Social, And Governance (ESG) Criteria

One of the methods that companies are using to measure the success of these types of programs is to base them on environmental, social, and governance (ESG) criteria. ESG investing is also sometimes referred to as sustainable investing, responsible investing, or socially responsible investing (SRI). The practice has become an increasingly popular way to promote the United Nations Sustainable Development Goals and was on full display at WEF 22.

While much of the conversation around ESG focused on corporations attempting to “go green”, many researchers suspect ESG-like criteria will eventually be applied to individuals as some form of social credit score.

For example, during a panel titled “Responsible Consumption”, Alibaba Group president, J. Michael Evans, discussed the importance of his company and others adopting the ESG criteria.

He also boasted about the development of an “individual carbon footprint tracker” to monitor what you buy, what you eat, as well as where and how you travel.

Evans also discussed how his company is working on incentivizing the public to use systems which encourage environmentally friendly behavior. [The system described by Evans](#) is part of the push towards consumer incentivization using points and rewards. These systems are another step in the direction of social credit scores.

“We have something within our business called A Map. So what we are going to do is allow people to calculate the best route, the most efficient route, and also the most efficient form of transportation. Then, if they take advantage of those recommendations we will give them bonus points that they can redeem elsewhere on our platform. So they are incentivized to do the right thing.”

Central Bank Digital Currencies

One of the most impactful topics being discussed was Central Bank Digital Currencies (CBDCs). A panel on CBDCs featured Kristalina Georgieva, Managing Director, International Monetary Fund; Sethaput Suthiwartnarueput, Governor, Bank of Thailand; François Villeroy de Galhau, Governor, Central Bank of France; and Axel Lehmann, Chairman of the Board of Directors, Credit Suisse AG.

When making the case for digital currencies controlled by Central Banks, Georgieva took some shots at cryptocurrencies. *“Bitcoin may be called a coin, but it’s not money. It’s not a stable store of value,”* she stated.

François Villeroy de Galhau, a governor with the Central Bank of France, called cryptocurrencies *“not a reliable means of payment”*.

The reason for this animosity towards private cryptocurrency use is that it is a thorn in the side of the globalists who seek to end the use of cash and all private financial exchanges that they cannot track and trace. The fact that CBDCs were discussed in several panels with high level authorities in their respective fields is an indication that CBDCs will continue to be an important part of the WEF’s Great Reset agenda.

YouTube Censorship

YouTube CEO Susan Wojcicki further cemented her company’s commitment to censoring information that does not align with the official narratives shilled by corporate media. Wojcicki made the comments to Alyson Shontell Lombardi, the Editor-in-Chief of Fortune Magazine, when asked whether YouTube’s efforts to censor misinformation will always be a “work in progress.”

“I think there’ll always be work that we have to do because there will always be incentives for people to be creating misinformation,” Wojcicki said. *“The challenge will be to keep staying ahead of that and make sure that we are understanding what they are and the different ways that people may use to try to trick our systems and make sure that our systems are staying ahead of what’s necessary to make sure that we are managing that.”*

YouTube has already deleted more than a million videos for “COVID misinformation,” plans to preemptively censor “new misinformation,” and has considered hiding the share button to prevent misinformation spread.

The Great Reset:

A picture how the great reset should work out



An interview with Vandana Shiva; a scholar environmentalist

Vandana Shiva, scholar environmentalist, food sovereignty advocate, explained in a interview “The Great Reset is about multinational corporate stakeholders at the World Economic Forum controlling as many elements of planetary life as they possibly can. From the digital data humans produce to each morsel of food we eat.”

The WEF describes itself as “the global platform for public-private cooperation” that creates partnerships between corporations, politicians, intellectuals, scientists and other leaders of society to “define, discuss and advance key issues on the global agenda.”

According to WEF’s founder and executive chairman, Klaus Schwab, the forum is guided by the goal of positioning “private corporations as the trustees of society” to “address social and environmental challenges.” In July, 2020 Claus Schwab published a 195-page book, “COVID-19: The Great Reset,” in which he challenged industry leaders and decision makers to “make good use of the pandemic by not letting the crisis go to waste.”

TIME magazine (whose owner Marc Benioff is a WEF board member) recently partnered with the WEF to cover The Great Reset and to provide a “look at how the COVID-19 pandemic provides a unique opportunity to transform the way we live.”

The Great Reset is meant to be all-encompassing. Its partner organizations include the biggest players in data collection, telecommunications, weapons manufacturing, finance, pharmaceuticals, biotechnology and the food industry. The WEF’s plans for the “reset” of food and agriculture include projects and strategic partnerships that favor genetically modified organisms, lab-made proteins and pharmaceuticals and industrial chemicals as sustainable solutions to food and health issues.

For example, WEF has promoted and partnered with an organization called EAT Forum. EAT Forum describes itself as a “Davos for food” that plans to “add value to business and industry” and “set the political agenda.”

EAT was co-founded by Wellcome Trust, an organization established with funds from GlaxoSmithKline and which still has strategic partnerships with the drugmaker. EAT collaborates with nearly 40 city governments in Europe, Africa, Asia, North America, South America and Australia. The organization also assists the United Nations Children’s Fund (UNICEF) in the “creation of new dietary guidelines” and sustainable development initiatives.

According to Federic Leroy, a food science and biotechnology professor at University of Brussels, EAT network interacts closely with some of the biggest imitation meat companies, including Impossible Foods and other biotech companies, which aim to replace wholesome nutritious foods with genetically modified lab creations.

Impossible Foods was initially co-funded by Google, Jeff Bezos and Bill Gates. Recent lab results showed the company’s imitation meat contained glyphosate levels 11 times higher than its closest competitor. EAT’s biggest initiative is called FReSH, which the organization describes as an effort to drive the transformation of the food system. The project’s partners include Bayer, Cargill, Syngenta, Unilever and even tech giant Google.

“Companies like Unilever and Bayer and other pharmaceutical companies are already chemical processors — so many of these companies are very well positioned to profit off of this new food business which revolves around processing chemicals and extracts needed to produce these lab-made foods on a global scale,” Leroy said.

In Schwab’s book, he discusses how biotechnology and genetically modified food should become a central pillar to repairing global food scarcity issues, issues which COVID has revealed and exacerbated. He writes “global food security will only be achieved if regulations on genetically modified foods are adapted to reflect the reality that gene editing offers a precise, efficient and safe method of improving crops.”

Shiva disagrees strongly on this point: “WEF is parading fake science,” and “for Mr. Schwab to promote these technologies as solutions proves that The Great Reset is about maintaining and empowering a corporate extraction machine and the private ownership of life.”

EAT developed what it refers to as “the planetary health diet,” which the WEF champions as the “sustainable dietary solution of the future.” But according to Leroy, it’s a diet that’s supposed to replace everything else. “The diet aims to cut the meat and dairy intake of the global population by as much as 90% in some cases and replaces it with lab-made foods, cereals and oil,” he said.

Shiva further explained; “EAT’s proposed diet is not about nutrition at all, it’s about big business and it’s about a corporate takeover of the food system.”

According to EAT’s own reports, the big adjustments the organization and its corporate partners want to make to the food system are “unlikely to be successful if left up to the individual,” and the changes they wish to impose on societal eating habits and food “require reframing at the systemic level with hard policy interventions that include laws, fiscal measures, subsidies and penalties, trade reconfiguration and other economic and structural measures.”

But Shiva said this is the wrong approach, because “all of the science” shows that diets should be centered around regional and geographical biodiversity. She explained that “EAT’s uniform global diet will be produced with western technology and agricultural chemicals. Forcing this onto sovereign nations by multinational lobbying is what I refer to as food imperialism.”

There’s not a single area of life that is left out of this Great Reset plan.

The planned reform will affect everything from government, energy and finance to food, medicine, real estate, policing and even how we interact with our fellow human beings in general.

Privacy protections, of course, are a major hurdle in this plan, which is why every effort is made to get people to loosen their views on the right for privacy. In the U.S., we also have the Constitution that stands in the way, which is why efforts to undermine, circumvent, ignore or nullify it are increasing.

“To sum it up, the desired end result is a giant, joyless, highly controlled global conveyor of everything and everybody where privacy is tremendously expensive, dissent is unthinkable, and spiritual submission is mandatory.

Stakeholder Capitalism

An October 5, 2020, Winter Oak article⁵ addressed the “technocratic fascist vision” of professor Klaus Schwab, founder and executive chairman of the World Economic Forum who wrote the book on the Fourth Industrial Revolution. Schwab announced the World Economic Forum’s Great Reset Initiative in June 2020, which includes stripping all people of their privately owned assets.

In addition to being a staunch technocrat, Schwab also has a strong transhumanist bend, and he has spoken of a near future in which humans merge with machines and in which law enforcement will be able to read our mind.

Winter Oak — a British nonprofit social justice organization — points out that Schwab and his globalist accomplices are using the COVID-19 pandemic “to bypass democratic accountability, to override opposition, to accelerate their agenda and to impose it on the rest of humankind against our will.”

This is no conspiracy theory. The plan is out in the open. As noted by Time magazine,⁷ “The COVID-19 pandemic has provided a unique opportunity to think about the kind of future we want.”

Schwab’s book: “COVID-19: The Great Reset” also urges industry leaders and decision makers to “make good use of the pandemic” and “not letting the crisis go to waste.”

Incidentally, the owner of Time magazine and founder of Salesforce, Mark Benioff, is also a board member of the World Economic Forum,¹⁰ so he’s clearly familiar with the reset plan.

The problem is that while the plan is being sold as a way to, finally, make life fair and equitable for all people, the required sacrifices do not apply to the technocrats running the system.

Ultimately, the Great Reset will result in two tiers of people: the technocratic elite, who have all the power and rule over all assets, and the rest of humanity, who have no power, no assets and no say-so in anything.

It is the World Economic Forum’s designation for a massive shift in all spheres of society on the back of the great crisis of 2020. Its author, Klaus Schwab, destroys any hope for our old society when he says:

“Many of us are wondering when things will return to normal. The short response is: never. The world as we knew it in the early months of 2020 is no more”.

The so-called ‘elites’, or greedy sociopaths, have taken it upon themselves to re-order the whole of the world economy and society. Going by current trends this reset will benefit the billionaire class massively at the expense of the rest of us.

World Economic Forum's 'Young Global Leaders' Is a massive network of royals, politicians, Big Tech, billionaires and other 'Elites'

The ultimate goal of the WEF is to Control & Change life on Earth by hacking into Humans & removing Free Will

Klaus Schwab

Klaus Schwab, founder and executive chairman of the World Economic Forum (WEF), is the personification of The Great Reset — the ultimate goal of which is to do away with the democratic process and give all ownership and control to the deep state — and the technocratic elite who control it.

Through its Young Global Leaders program, the World Economic Forum has been instrumental in shaping a world order that undermines all democratic principles. For several decades, this program has nurtured compliant leaders acting as WEF agents in governments around the world. The consequences are far-reaching and may turn out to be devastating for humanity.

Sponsors of WEF's Young Global Leaders Program include the Bill & Melinda Gates Foundation and Google — "I wonder why Google censors and shapes information to be in exact support of the World Economic Forum's narrative?" Sears asks.

In 1992, Klaus Schwab and the World Economic Forum launched a program initially called: "Global Leaders of Tomorrow", through which the WEF actively indoctrinates "young leaders". WEF maintains this "Young Global Leaders" program, a five-year indoctrination into their principles. Its goal is to create world leaders who don't answer to their people but to their bosses at WEF. In 2004, this program was turned into the Forum for Young Global Leaders. Graduates of the program include world leaders who are "suspiciously in lockstep" with WEF's Great Reset, such as:

- * Justin Trudeau, prime minister of Canada
- * Emmanuel Macron, president of France
- * Mark Zuckerberg, cofounder and CEO of Facebook

The aim was – and is – to find suitable future leaders for the emerging global society. The program has since its inception has included politicians, business leaders, royalty, journalists, performers and other cultural influencers who have excelled in their fields but have not yet turned 40 years of age (originally 43 in order to include Angela Merkel).

It has since grown into an extensive global network of dedicated leaders with enormous resources and influence, all working to implement the technocratic plans of the World Economic Forum in their respective nations and fields.

“The network creates a force for worldwide influence through the combination of the individual skills and resources of its members.” As Klaus Schwab says in the introductory quote, it has become very successful. Already in the first year, 1992, a number of highly influential candidates were elected. Among 200 selected were global profiles such as Angela Merkel, Tony Blair, Nicolas Sarkozy, Billy Boy, Bono, Richard Branson (Virgin), Jorma Ollila (Shell Oil), and José Manuel Barroso (President of the European Commission 2004–2014).

Another “Global Leader of Tomorrow” 2000 was Chrystia Freeland, Deputy Prime Minister and Minister of Finance of Canada, a journalist and author who was previously managing director of Thomson Reuters and deputy editor of the Financial Times. She is also a board member of the World Economic Forum.

“As Foreign Minister, she led and successfully concluded the renegotiation of the North American Free Trade Agreement (NAFTA) between Canada, Mexico, and the United States. In November, 2019, Ms. Freeland was appointed Deputy Prime Minister of Canada and Minister of Intergovernmental Affairs. In this capacity, she led Canada’s united response to the COVID-19 pandemic.”

The purpose from the beginning has been to “identify and advance a future-oriented global agenda, focusing on issues at the intersection of the public and private sectors.” Public–Private Partnerships is one of the cornerstones of the World Economic Forum philosophy. That is, a merger between state and large companies (also known as corporativism) with the aim of solving global problems of in a more “effective” way. The choice of leaders clearly reflects this aspiration.

The Young Global Leaders group was initially instructed to identify the major challenges of the 21st century. These included peace, the environment, education, technology and health – areas which these upcoming leaders could exploit politically, economically, and culturally in the new millennium.

Partners for Global Leaders of Tomorrow in 2000 were large global companies such as The Coca Cola Company, Ernst & Young, Volkswagen, and BP Amoco. These could contribute to the agenda by “playing an active role in developing and implementing the concept of the GLT project. The partners can therefore actively participate in the development of GLT programs; representatives of the partner companies as well as their guests are invited to GLT meetings .. ”

Since the Global Leaders of Tomorrow was turned into Young Global Leaders 2004, partners such as the Bill & Melinda Gates Foundation, Google, and JPMorgan Chase have also participated as sponsors.

The ultimate consequence of both public–private partnerships and these target areas is the creation of a largely fascist social contract in which the individual has become subordinated to these powerful interests. Noble goals of creating a better world have also been kidnapped. This is especially evident in the context of the partnership between the WEF and the UN and the implementation of the global goals (Agenda 2030) through the application of the technologies of the Fourth Industrial Revolution.

This means that the democratic principles and division of power of the 20th century have largely been completely undermined and instead replaced by a new global class that shapes our common future based on their own interests. This has led to a de facto privatization of both national governments and international organizations, where lobbyists are no longer kept in the lobby but have moved into the seat of power, shaping policies directly affecting our lives. What this means has become particularly evident since the pandemic was declared in March 2020.

In addition, leading multinational investment management corporations such as BlackRock, led by the World Economic Forum's own Larry Fink, have constantly moved their positions forward. German economist and journalist Ernst Wolff believes that many of the national leaders included in the Young Global Leader program have been selected for their willingness to carry out the tough agenda of lockdowns in recent years without asking any questions, and that their impending failure (as evidenced by in a growing dissatisfaction of the masses) will be used as an excuse to create a new form of Global Government where the old nation states become largely obsolete. A new global digital currency with Universal Basic Income (UBI) can then be gradually introduced.

Acute Crisis Boosts the Power of the State

WEF operates via fearmongering — about disease and environmental catastrophes, for starters. When the population is controlled by fear, it welcomes authoritarian “protections” like increased surveillance and digital identity systems, introduced under the guise of safety, but which ultimately remove personal autonomy and freedom.

In fact, Schwab wrote, “One of the greatest lessons of the past five centuries in Europe and America is this: Acute crisis contributes to boosting the power of the state. It's always been the case, and there is no reason why it should be different with the COVID-19 pandemic.”

WEF portrays itself as a global organization committed to improving the state of the world, but most would be taken aback if they knew who's behind it. As Sears put it:

“You'll be excited to hear that the lineup of World Economic Forum's speakers at their annual gathering of elites in Davos included such benevolent humanitarians like Xi Jinping, the leader of the Chinese Communist Party, who's currently committing genocide, and Tony Fauci, who's arguably involved in crimes against humanity, and Bill Gates, who's arguably involved in crimes against humanity, and Australian Prime Minister Scott Morrison, who's arguably currently involved in crimes against humanity. What a great line up!”

Committed to Reengineering Life Itself

WEF's goal isn't to just control life on Earth but to fundamentally change it. Schwab's top adviser, transhumanist Dr. Yuval Noah Harari, openly admits data might enable human elites to do more than "just build digital dictatorships."

"By hacking organisms," Harari said, "elites may gain the power to re-engineer the future of life itself. Because once you can hack something, you can usually also engineer it."5 Soon, he says, some corporations and governments will be able to "systematically hack all the people." And if they succeed in hacking life, he describes it as the "greatest revolution in biology since the beginning of life 4 billion years ago." According to Harari.

"For 4 billion years, nothing fundamental changed. Science is replacing evolution by natural selection with evolution by intelligent design. Not the intelligent design of some god above the clouds, but our intelligent design, and the intelligent design of our clouds — the IBM cloud, the Microsoft cloud — these are the new driving forces of evolution."

Once human life is hacked, the hackers will maintain control over life itself — a process that has been accelerated by the pandemic. After all, Harari said, "It's often said that you should never let a good crisis go to waste."

Surveillance is a key part of the plan for global totalitarian control, and Harari says that in 100 years, people will be able to look back and identify the COVID-19 pandemic as the moment when a new regime in surveillance took over — "especially surveillance under the skin."

How Will People 'Own Nothing and Be Happy'?

If WEF and Schwab are intent on moving ahead with their plan for global domination, they'll need to get people on board with the idea of giving up ownership to an elite class. But how? Bring in BlackRock, an investment firm that has \$9 trillion under management — a higher GDP than every country on Earth aside from the U.S. and China, JP Sears says. (This man is a comedian by profession, but also delivers a very serious message...)

BlackRock has more power than most governments on Earth, and it also controls the Federal Reserve, Wall Street mega-banks like Goldman Sachs and the WEF's Great Reset, according to F. William Engdahl, a strategic risk consultant and lecturer who holds a degree in politics from Princeton University.

So, what's the connection with the World Economic Forum? Blackrock founder and CEO Larry Fink is a WEF board member. Sears poses the question: "Is the World Economic Forum and Blackrock colluding in corporatism, where an unelected corporate elite dictates top down to the population?"

To do this, they'd need to infiltrate the government — and they have. Brian Deese, the U.S. director of National Economic Council, was formerly BlackRock's global head of sustainable investing. "Now he's Biden's main adviser for economic policy," Sears says.

Vice President Kamala Harris' chief economic adviser Michael Pyle also came from BlackRock, where he was a global chief economic strategist.

"It looks like corporatism but it's probably not," Sears says jokingly. "But if it was, it would actually be a viable strategy for BlackRock and the World Economic Forum to own everything and for you to own nothing."

BlackRock is also buying up single family homes at an alarming rate, paying up to 50% above asking price so “average” people can’t buy them. Why is BlackRock interested in overpaying for modest, single family homes?

In a Twitter thread posted by user Culturalhusbandry, it’s noted:

“Black Rock, Vanguard, and State Street control 20 trillion dollars’ worth of assets. Blackrock alone has a 10 billion a year surplus. That means with 5-20% down they can get mortgages on 130-170k homes every year. Or they can outright buy 30k homes per year. Just Blackrock.

... Now imagine every major institute doing this, because they are. It can be such a fast sweeping action that 30yrs may be overshooting it. They may accomplish feudalism in 15 years.”

If the average American is pushed out of the housing market, and most of the available housing is owned by investment groups and corporations, you become beholden to them as your landlord. You’ll then own nothing, not even your home. All items and resources are to be used by the collective, while actual ownership is restricted to an upper stratum of social class.

Schwab Wasn’t the Mastermind Behind the WEF

If Schwab is the most dangerous person alive today, his predecessors deserve honorable mentions. In an investigative report by journalist Johnny Vedmore, it’s revealed that Schwab wasn’t the mastermind behind WEF and The Great Reset.

That honor goes to his three mentors — John K. Galbraith, a Canadian-American economist, diplomat and public policy maker, Herman Kahn, who created concepts on nuclear deterrence that became official military policy, and Henry A. Kissinger, who recruited Schwab at a Harvard international seminar, which was funded by the U.S. CIA.

“If you have a decent knowledge of Klaus Schwab’s history, you will know that he attended Harvard in the 1960s where he would meet then-professor Henry A. Kissinger, a man with whom Schwab would form a lifelong friendship,” Vedmore explained.

“My research indicates that the World Economic Forum is not a European creation. In reality, it is instead an operation which emanates from the public policy grandees of the Kennedy, Johnson and Nixonian eras of American politics; all of whom had ties to the Council on Foreign Relations and the associated “Round Table” Movement, with a supporting role played by the Central Intelligence Agency.

There were three extremely powerful and influential men, Kissinger among them, who would lead Klaus Schwab towards their ultimate goal of complete American Empire-aligned global domination via the creation of social and economic policies.

In addition, two of the men were at the core of manufacturing the ever present threat of global thermonuclear war ... their paths would cross and coalesce during the 1960s ... they recruited Klaus Schwab through a CIA-funded program, and ... they were the real driving force behind the creation of the World Economic Forum.”

Your Free Will Is Under Attack

Environmental pollution, disease and cyberattacks are being used to generate fear in order to keep the population compliant. Another part of The Great Reset is a reset of the economy, including jobs. Many across the U.S. are facing unemployment if they do not choose to take a genetic therapy experiment in the form of a COVID-19 shot.

It's clear that the COVID-19 pandemic has created "a unique window of opportunity" to rapidly usher in the Great Reset, which involves changing everything from future global relations and the direction of national economies to "the priorities of societies, the nature of business models and the management of a global commons."

Part of the plan involves the Fourth Industrial Revolution, which Schwab has been discussing since at least 2016 and "is characterized by a fusion of technologies that is blurring the lines between the physical, digital, and biological spheres."

In terms of government, the Revolution will bring new technological powers that allow for increased population control via "pervasive surveillance systems and the ability to control digital infrastructure." Meanwhile, while people are busy worrying about the orchestrated threats that are out to get them, technocrats are working on how to remove the essence of what it means to be human — namely, free will.

"Humans are now hackable animals," Harari said. "Humans have this soul or spirit and they have free will, and nobody knows what's happening inside me, so whatever I choose, whether in the election or whether in the supermarket, this is my free will — that's over." It's urgent that we all take steps to remain free, sovereign individuals, which can be as straightforward as:

"We are in the process of either The Great Reset or the Great Awakening," Sears points out, "and the choice isn't Klaus Schwab's. The choice is yours."

The purpose of The Great Transition Initiative is to implement a totalitarian "New Earth Order" and to set up a global democratic government (Earth Federation) with a World Constitution.

"The COVID-19 pandemic has underscored the catastrophic failure of an every-country-for-itself approach to public health, and national economic interests, rather than global needs, continue to dominate discussions of climate policy, paving the path toward climate chaos.

Under the tricameral World Parliament come the four main agencies of the Earth Federation government: the World Supreme Court system, the World Executive, the World Enforcement System, and the World Ombudsman." – Glen T. Martin, The Earth Constitution.

The vision is that a peaceful and harmonious world in balance is created through the establishment of a World Federation with a World Parliament, World Government and a World Court. These are ideas that have long circulated in Club of Rome and closely connected New Age circles. The question is how such a new global system of power would escape the fate of being kidnapped by the same interests that created our current corrupt and failing system? This is in view of those who support projects such as The Great Transition (initiated with start-up capital from Steven Rockefeller). Translation: Big brother big data surveillance state

Globalists tracking your “individual carbon footprint”

Total control over travelling, food and consumption of goods

The World Economic Forum (WEF) met in Davos, Switzerland to discuss the future of controlling humanity. J. Michael Evans, president of the Alibaba Group, talked about the development of an “individual carbon footprint tracker.”

“We’re developing through technology an ability for consumers to measure their own carbon footprint,” said Alibaba’s Michael Evans. “What does that mean? That’s where they’re traveling, how they’re traveling, what are they eating, what are they consuming on the platform. Individual carbon footprint tracker. Stay tuned, we don’t have it operational yet but this is something that we are working on,” he added.

Chinese mega corporation to unleash new carbon footprint tracking technology

This carbon footprint tracker technology (from China) is designed to track and control every person's travel and consumption of food, energy and other goods. To accomplish these goals of surveillance and control, the world elite would either have to use injectable or implantable surveillance technology or reset the global economy with a digital currency that can track and restrict everyone's purchases and travel abilities. This tracking technology could be adapted into vehicles to restrict a person's travel and interfere with their autonomy and freedom. The card features the slogan “DO. Everyday Climate Action” and also has a piece of propaganda on the back side which states “I am taking responsibility for every transaction I make to help protect the planet” which reads like 2nd grade brainwashing. Note the symbolism of the all-seeing eye on the back side of the card in the image above, taking from the UN's SDGs (Sustainable Development Goals), specifically goal #13, which states: “Take urgent action to combat climate change and its impacts.”

[Emissions Trading Scheme 2.0: EU approves carbon tax on heating and transport.](#)

After marathon negotiations, politicians agreed to start pricing carbon emissions from burning fossil fuels for road transport and heating in 2027, with a price cap of €45 per tonne of carbon emitted that will apply until 2030.

EU lawmakers agreed on Sunday (18 December) to introduce a carbon price for buildings and road transport fuels, while setting up a new €87 billion social climate fund to cushion the impact on households and help them invest in green solutions.

The new carbon price will apply to petrol, diesel and heating fuels such as natural gas, whose global warming emissions have continued to rise over the years despite efforts to decarbonise them.

ETS2 was probably the most controversial issue in the negotiations to reform the EU Emissions Trading Scheme (ETS), the world's largest carbon market and the bloc's flagship climate policy.

After marathon talks, that began on Friday and concluded on Sunday morning (18 December), negotiators agreed to start pricing carbon emissions from fossil fuel combustion for road transport and heating in 2027, with a price cap of €45 per tonne of carbon emitted that will apply until 2030.

The agreement also covers "process heat" as generated in industrial activities and office heating.

Agriculture and fisheries do not have to pay the extra carbon costs because they are "sensitive" sectors. Trains running on diesel are also outside the scope of the scheme and, as a result, will not be taxed on their carbon emissions. Of course, the new scheme entails higher prices at the pump.

Prices will also rise for heating fuels such as gas, fuel oil and coal, to the detriment of poorer EU member states, which are more dependent on dirty fossil fuels.

"EU citizens should expect higher CO2 prices," said Michael Bloss, a Green lawmaker who took part in the latest ETS negotiations. Due to the ongoing energy crisis, the new scheme could be delayed for a year, until 2028, if energy prices remain "exceptionally high", it said in a statement.

The provisional agreement must now be confirmed by EU member states and the European Parliament, which will vote in plenary in January or February.

The 87 billion euro social climate fund

Negotiations on the emissions trading scheme for buildings and road transport - known as ETS2 - dragged on until Sunday because the introduction of what many will see as a new tax is politically sensitive.

Pascal Canfin, the chairman of Parliament's environment committee, had initially warned against the system. He said it was "politically suicidal" and risked creating a movement across Europe similar to the Yellow Vests in France.

Aware of this risk, lawmakers agreed to set up a new social climate fund to protect EU households from rising fuel costs.

According to the agreement, the fund amounts to €87 billion and will be paid out from 2026, one year before the new carbon price applies. It will be funded by ETS2 revenues, with 25% of the funding coming from EU countries.

The funds will be effectively ring-fenced, with a provision stating that ETS2 revenues not going directly to the social climate fund "will be prioritised" to mitigate the impact on vulnerable groups.

"The social climate fund will help vulnerable households with the energy transition, for example with insulation vouchers or switching to greener transport options," said Esther de Lange of the EPP, who negotiated the fund with Casa.

Green politicians, however, were more critical, saying the fund "is not enough to offset this burden", said Michael Bloss, a Green MEP.

"The EU's climate protection has an anti-social bias," Bloss said.

Nitrogen “pollution”

Agenda 2030 in full swing – Political pushback – Farmers are not rolling over

Dutch farmers are protesting against nitrogen plans throughout The Netherlands. According to our leaders, the world is suffering from the effects of climate change. Climate change has major consequences for people, nature and the environment due to the increase in greenhouse gases, especially CO₂. So they say.

In the Netherlands, however, the CO₂ problem appears to be somewhat less pressing. Instead, the government is particularly concerned about nitrogen. The problem is so big that under Rutte IV, an actual nitrogen minister, Christianne van der Wal-Zeggelink, has been appointed to solve the problem. This is having major implications for Agriculture, Infrastructure, Industry and Construction. The minister writes:

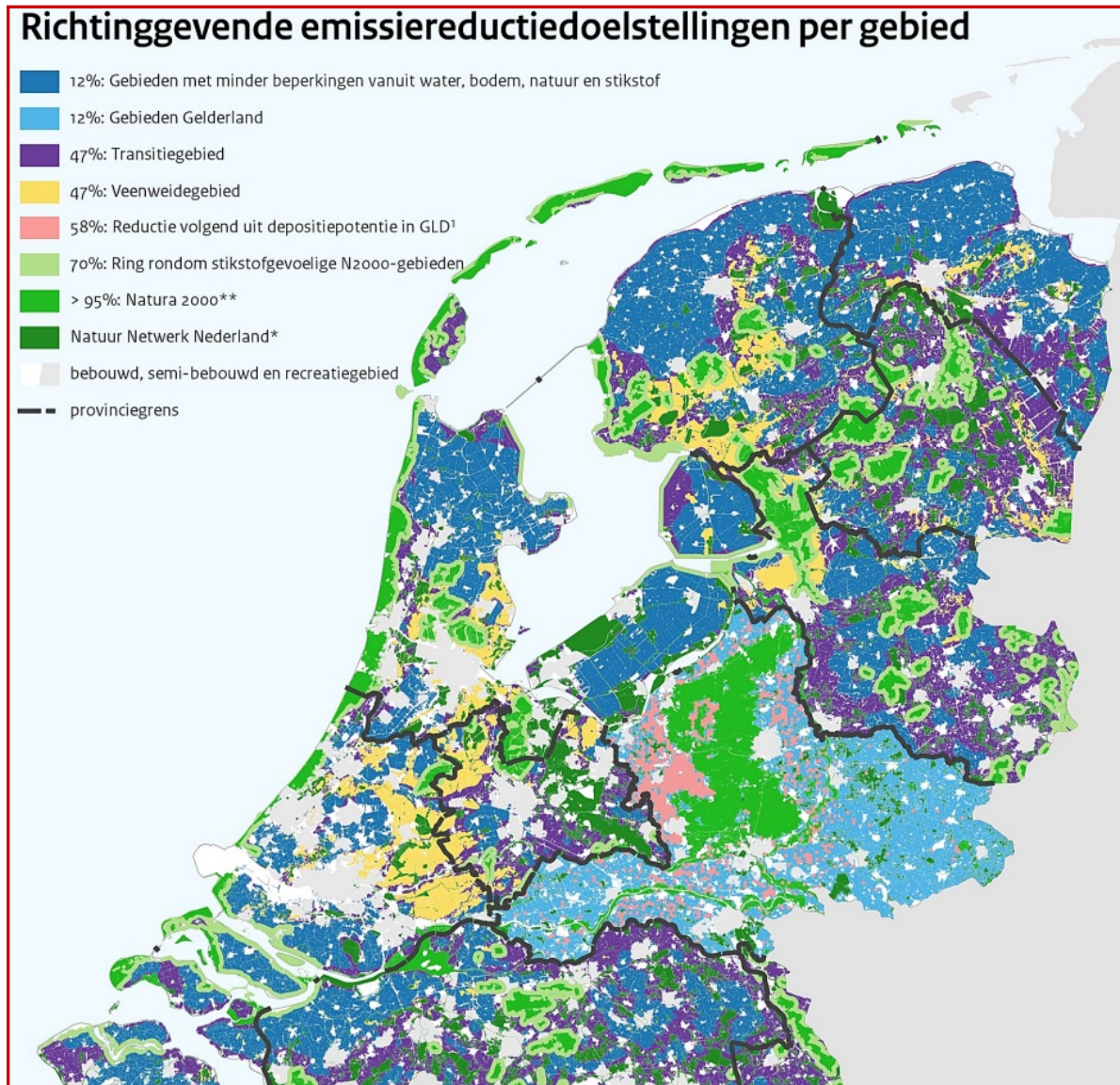
“much of the total nitrogen precipitation comes from agriculture. This is mainly in the form of ammonia, a colorless gas. This gas is released when urine comes into contact with animal manure. Ammonia is also released when fertilizing the land.”

Three weeks ago, the minister presented plans for the agricultural sector. A color map indicates how much emission reduction must be achieved per area. This varies from 12%, to areas where a >95% reduction must take place. The greener an area on the map, the more one needs to reduce. The high reduction areas are mainly zones near so-called Natura 2000 areas.

However, the minister is flexible. Van der Wal emphasizes that these are ‘directive emission reduction targets’. “The only thing I really aim for is that the sum of all those provinces together results in 50 percent less nitrogen emissions.” These plans need to be met by 2030.

Fierce criticism from across the political spectrum

Coalition party CDA (Christian Democrat Appeal), traditionally a party of which many farmers are members, is clearly having a tough time dealing critically with the nitrogen minister's plans given that its leader, Wopke Hoekstra, serves as a World Economic Forum puppet. The CDA could therefore be reduced to a splinter party in the next elections (If elections are held fairly). Farmers are now flocking en masse to a party like BBB (ER: the Farmer-Citizen Movement, an agrarian movement founded in 2019 by Caroline van der Plas), which is now the second largest party in the polls. For the time being, however, BBB only has one seat in the House of Representatives.



The opposition has focused mainly on the scientific report of the RIVM (ER: the National Institute for Public Health and the Environment), on which the plans of the nitrogen minister are based. Caroline van der Plas, leader of BBB, pointed to outdated graphs included in the RIVM report. She also finds it strange that the Wadden Islands (ER: very tiny islands compared to other islands ringing The Netherlands in the North Sea – see map below) are colored green on the color map, but there are hardly any farmers on the smaller islands. She points out that even if all the people and livestock were to leave the islands, the standards would not be met.

Farmers Protest Globalist Nitrogen Plans Throughout The Netherlands

Dutch farmers are being basically subjected to the anti-nitrogen policies that are destroying their livelihoods on the basis of a ‘nitrogen problem’.

It’s Agenda 21 being played out with a new culprit. Find a reason to seize land, kill farm animals and cut food production to the human population, all of which affects other sectors of the economy. Then publicly panic because there are going to be food shortages. A reminder that the Netherlands is the world’s 5th largest food exporter.

Dutch PM Mark Rutte, multiply-(s)elected, is a deep-rooted globalists as far as can be told and a World Economic Forum graduate.

Farmers from the world’s 5th largest exporter of food are demanding that the Hague immediately reverse course, and have blocked the border between Holland and Germany over the rule which would lead to the closure of dozens of farms and cattle ranches.

In 2021, the Netherlands’ coalition government proposed slashing livestock numbers in the country by 30 percent to meet nitrogen emissions targets. The country has already implemented stringent restrictions on new construction with the aim of curbing nitrogen emissions.

Rabobank has argued that those new hurdles have slowed down home-building in the Netherlands, intensifying a housing shortage in the densely populated coastal nation.

On June 10, the government issued a national and area-specific plan for curbing nitrogen emissions. Those emissions are heavily driven by ammonia from livestock manure. Some parts of the country would have to slash those emissions by 70 or even 95 percent.

It openly acknowledged that “there is not a future for all Dutch farmers within this approach,” as reported by the U.S. Department of Agriculture’s Foreign Agriculture Service.

“The Minister of Nature and Nitrogen Policy expects about a third of the 50,000 Dutch farms to ‘disappear’ by 2030,” the New Zealand Ministry of Foreign Affairs and Trade reported in a June 23 Market Insight Report.

The Netherlands is the world’s fifth-largest exporter of food, exceeded only by the United States, Germany, the United Kingdom, and China, according to World Bank statistics.

The Dutch government offers a multibillion-dollar buyout arrangement for farmers. Christianne van der Wal, minister of nature and nitrogen policy, has left open the possibility that the government will expropriate land from farmers who do not comply, as reported by NOS Nieuws. The proposals and resultant protests come amid worldwide fertilizer and food shortages.

Artificial Famine by food speculation:

2022: Global food prices surge to record highs; FAO warns of famine all over the world

The Food and Agriculture Organization (FAO) of the United Nations reported that global food prices soared above all-time highs in March as a consequence of unsolved supply chain issues and the economic fallout from the war in Ukraine.

In March 2022, the FAO's food price index increased to its third straight record high. It jumped by nearly 34 percent from the same time last year. Furthermore, the FAO said that its food price index, which also tracks monthly changes in international prices for a basket of commodities, averaged 159.3 points in March – up by 12.6 percent from its February numbers. The organization called this a “giant leap.”

FAO Deputy Director-General Beth Bechdol placed most of the blame for the surging food prices on the war in Ukraine. “The ongoing conflict in Ukraine is heightening concerns about the impact on food security worldwide,” said Bechdol. “We are witnessing food price increases across the board.”

According to estimates from both the FAO and the Ukrainian government, between 20 to 30 percent of land in Ukraine that used to produce winter grains, corn and sunflower will go unplanted this spring or will be unharvested by July and August. This massive drop in food production in Ukraine will lead to a global gap between supply and demand in food for human consumption and feed for livestock. This could raise international prices by another eight to 22 percent above their already significantly elevated levels.

Ukraine and Russia together account for around 30 percent of the global wheat trade. While Russia has attempted to continue shipping wheat since the invasion of Ukraine started, Western-led economic sanctions have complicated payments, leading to massive uncertainty regarding wheat supply. This loss of wheat exports has exacerbated fears that parts of the world that are reliant on Ukrainian and Russian agricultural exports will experience a famine.

Other sizable grain exporters like Argentina, Australia, Canada, France and the U.S. are trying to make up for the decreased wheat production. But farmers in these countries are struggling to increase grain exports due to rising fuel and fertilizer costs cutting into their output. If these countries can increase output, it will take a long time before countries that rely on Ukrainian and Russian agricultural exports feel the difference. In 2021, 36 out of 55 countries that were experiencing food crises depended on Ukrainian and Russian exports for more than 10 percent of their total wheat imports, including 21 countries whose food crises are considered severe or major.

If the shortage of food commodities caused by the war and the debilitating sanctions persists, FAO predicted that the global number of undernourished people could increase from eight million to 13 million. Most of these people will come from the Asia-Pacific region, followed by sub-Saharan Africa, North Africa and East Africa. For consumers in advanced economies, food costs account for around 17 percent of spending. People in developing countries spend a significantly higher proportion of their earnings on food, sometimes more than double what consumers in the developed world spend. For people in sub-Saharan Africa, for example, food accounts for up to 40 percent of their spending. These proportions are expected to get significantly worse the longer the conflict and the fallout from it drag on.

Banksters and Hedge Funds speculating on food gives a price boost

Banks are earning huge profits from betting on food prices in unregulated financial markets. This creates instability and pushes up global food prices, leaving millions going hungry and facing deeper poverty. In January 2014, after four years of our campaign, the EU agreed to introduce new rules to prevent hedge funds and investment banks from driving up food prices.

Banks, hedge funds and pension funds are betting on food prices in financial markets, causing drastic price swings in staple foods such as wheat, maize and soy. In this way they can make a profit, but this results in a price increase of these food products at the expense of the less wealthy citizens. These markets were originally developed for the benefit of those involved in the production of food, yet over the last 10 years they have changed almost beyond recognition. Deregulation has enabled speculators to dominate, causing drastic spikes and crashes in prices.

Massive food price increases are catastrophic for people in poverty in the global south, who spend most of their income on food. This results in:

- Increased hunger as food becomes unaffordable.
- Malnutrition as smaller quantities of expensive foods such as fruit and vegetables are eaten in order to afford staple foods.
- Increased burden on women to earn more money by taking up risky employment such as sex work or domestic work.
- Households using up savings, going into debt or selling assets to pay for food.
- Families unable to afford healthcare and education as more of their income is needed to buy basic food.

In the last six months of 2010 alone, more than 44 million people were driven into extreme poverty as a result of rising food prices. At the same time, banks and financial investors are making a killing. We estimate that Barclays makes up to £340 million a year from betting, or speculating, on food prices. In the last five years, the amount of financial speculation on food has nearly doubled, from \$65 billion to \$126 billion.

Our report, *The Great Hunger Lottery* explains food speculation and its impacts on the world's poorest people while a later report, *Broken Markets* provides a more technical explanation of how financial speculation drives up food prices. 'Futures contracts' have been used for hundreds of years, helping farmers deal with the uncertainty of growing crops (such as unforeseen weather conditions). A futures contract means a farmer can sell his or her crops at a future date at a guaranteed price. However, these contracts can also be bought and sold by speculators who have no interest in the actual food being traded. Instead, by buying and selling the contracts they could profit from the prices changing over time – betting on the price of food.

These markets for futures contracts worked well until the late 1990s, when aggressive lobbying by bankers led to regulations being rolled back. New and complicated financial products created more ways to make money from betting on food.

Since 1996, the share of the markets for basic foods like wheat held by speculators – who have no connection to food – has increased from 12 per cent to 61 per cent. And further down the road, if we leave it only to the market, this percentage will increase further. United Nations special rapporteur on the right to food, Olivier de Schutter, September 2010: “The global food price crisis that occurred between 2007 and 2008, and which affects many developing countries to this day, had a number of causes. The initial causes related to market fundamentals, including the supply and demand for food commodities, transportation and storage costs, and an increase in the price of agricultural inputs. However, a significant portion of the increases in price and volatility of essential food commodities can only be explained by the emergence of a speculative bubble.”

French president, Nicolas Sarkozy, January 2011: “If we do nothing, we risk having food riots in the poorest countries and also an unfavourable impact on global growth. We want regulation of the financial markets for commodities.”

Then director-general of the UN Food and Agriculture Organisation (FAO), Jacques Diouf, January 2011: “[There is] a pressing need for new measures of transparency and regulation to deal with speculation on agricultural commodity futures markets.”

Civil society groups in the global south

La Via Campesina, international movement of small scale food producers, October 2011: “Financial speculation is and has been widely recognised as the major cause of the food crisis of 2007-2008 and should therefore be efficiently stopped at the international or regional level if we really want to prevent this from happening again.”

80 NGOs including Labour, Health and Human Rights Development Centre, Nigeria, Centre For Social Concern, Malawi, and Grupo de Solidaridad-Arenal, Nicaragua, March 2010: “Undue influence on food and energy commodity prices by speculators continues today as seen in unusually high oil prices... With global food production heavily dependent on oil ... volatile energy commodity prices means volatile food prices.”

Financial experts

Manager of Masters Capital Management hedge fund, Michael Masters, May 2008: “Are institutional investors contributing to food and energy price inflation? ... My unequivocal answer is “YES.” ... What we are experiencing is a demand shock coming from a new category of participant in the commodities futures markets: ... pension funds, sovereign wealth funds, university endowments and other institutional investors. Collectively, these investors now account on average for a larger share of outstanding commodities futures contracts than any other market participant.”

Chief economist of Goldman Sachs, Jim O’Neill, April 2009: “I see so much focus on food, and it seems to be so trendy in the investment world. ... The markets seem to me to have a bubble-like quality.”

Chairman of the US regulator, Commodity Futures Trading Commission, Gary Gensler, June 2009: “Over the past few years, price spikes and unprecedented volatility in the commodity markets have hurt farmers, consumers and businesses.”

Academics

Professor of economics at Jawaharlal Nehru University, New Delhi, Jayati Ghosh, May 2010: “Globally the world trade prices of food have been rising since about April 2009, and all the indications are that they’re rising for the same reasons that they rose way back in 2007-2008, which is to say that it’s not driven so much by global supply and demand factors, but it’s driven by financial involvement in the commodity futures markets.”

18 economists including Ilene Grabel and Martin Wolfson in a letter to US Congress, June 2010: “Deregulation that began in 2000 ... encouraged hyper-speculative activities by market players who had no interest in the underlying physical commodities being traded. This produced severe price swings for both oil and food in 2008-09 and destabilized business and household budgets in the US and throughout the world.”

Business leaders

Founder of Virgin Group, Sir Richard Branson, October 2010: “There is strong evidence that speculation exacerbated the last oil and food bubble. Speculation will fuel the next one too, unless meaningful speculative position limits are established.”

Chief executive of Unilever, Paul Polman, January 2011: “One of the main things in food inflation is that it has attracted the speculators for short-term profit at the expense of people living a dignified life. It is difficult to understand that if you really want to work for the long-term interests of society.”

Chief executive of Starbucks, Howard Schultz, May 2011: “Without any real supply or demand issues we are witness to the fact that most agricultural food commodities are at record highs at once, and coffee is at a 34-year high. Through financial speculation ... the commodities market is in a very unfortunate position.”

The WEF & the pandemic

In which way is the Davos World Economic Forum involved in the coronavirus pandemic?

The Davos World Economic Forum (WEF) is a premier forum for governments, global corporations and international entrepreneurs. Founded in 1971 by engineer and economist Klaus Schwab, the WEF describes its mission as “shaping global, regional and industry agendas” and “improving the state of the world”. According to its website, “moral and intellectual integrity is at the heart of everything it does.”

[The WEF has been involved in the coronavirus pandemic in several ways.](#)

First, the WEF was, together with the Gates Foundation, a sponsor of the prescient “Event 201” coronavirus pandemic simulation exercise, held in New York City on October 18, 2019 – the same day as the opening of the Wuhan Military World Games, seen by some as “ground zero” of the global pandemic. China itself has argued that US military athletes may have brought the virus to Wuhan.

Second, the WEF has been a leading proponent of digital biometric identity systems, arguing that they will make societies and industries more efficient, more productive and more secure. In July 2019, the WEF started a project to “shape the future of travel with biometric-enabled digital traveler identity management”.

In addition, the WEF collaborates with the ID2020 alliance, which is funded by the Gates and Rockefeller foundations and runs a program to “provide digital ID with vaccines”. In particular, ID2020 sees the vaccination of children as “an entry point for digital identity.”

Third, WEF founder Klaus Schwab is the author of the book COVID-19: The Great Reset, published in July 2020, which argues that the coronavirus pandemic can and should be used for an “economic, societal, geopolitical, environmental and technological reset”, including, in particular, advancing global governance, accelerating digital transformation, and tackling climate change.

Political leaders connected to the WEF and zero Covid tolerance measurements

Finally, the WEF has been running, since 1993, a program called “Global Leaders for Tomorrow”, rebranded, in 2004, as “Young Global Leaders”. This program aims at identifying, selecting and promoting future global leaders in both business and politics. Indeed, quite a few “Young Global Leaders” have later managed to become Presidents, Prime Ministers, or CEOs (see below). In a speech in 2017, WEF founder Klaus Schwab described this process as “penetrating the Cabinets”.

During the coronavirus pandemic, several WEF Global Leaders and Global Shapers (a junior program of the Global Leaders) have played prominent roles, typically promoting zero-covid strategies, lockdowns, mask mandates, and ‘vaccine passports’. This may have been a (largely failed) attempt to protect public health and the economy, or it may have been an attempt to advance the global transformation agenda outlined above, or perhaps both.

In this regard, some notable Young Leaders include Jeffrey Zients (US White House Coronavirus Response Coordinator), Stéphane Bancel (CEO of Moderna), Jeremy Howard (founder of influential lobby group “Masks for All”), Leana Wen (zero-covid CNN medical analyst), Eric Feigl-Ding (zero-covid Twitter personality), Gavin Newsom (Governor of California, selected in 2005), Devi Sridhar (British zero-covid professor), Jacinda Ardern (Prime Minister of New Zealand), Greg Hunt (Australian Health Minister and former WEF strategy director), French President Emmanuel Macron, Austrian Chancellor Sebastian Kurz, German Chancellor Angela Merkel (selected in 1993), German Health Minister Jens Spahn, and former British Prime Minister Tony Blair (a leading proponent of ‘global vaccine passports’). In the past Canadian Prime Minister Justin Trudeau has been a WEF keynote speaker.
